LEGISLATIVE BUSINESS

Following Private Members' Bills were passed by the Senate:-

- 1) The Bill further to amend the Oil and Gas Regulatory Authority Ordinance, 2002 [The Oil and Gas Regulatory Authority (Amendment) Bill, 2015], introduced by Senator Sassui Palijo, as reported by the Standing Committee.
 - The Minister for Law and Justice raised some objection which he stated that the Ministry also raised at Committee stage but remained unentertained.
 - After clause by clause consideration of the Bill, the Bill was passed unanimously by the House.
- 2) The Bill to amend the National Counter Terrorism Authority Act, 2013 [The National Counter Terrorism Authority (Amendment) Bill, 2016], introduced by Senator Farhatullah Babar, as reported by the Standing Committee.
 - The Bill was not opposed by the Minister of State for Interior.
 - After clause by clause consideration of the Bill, the Bill was passed unanimously by the House.
- 3) The Bill further to amend the Representation of the People Act, 1976 [The Representation of the People (Amendment) Bill, 2016], introduced by Senator **Sherry Rehman,** as reported by the Standing Committee.
 - The Law Minister suggested that since the Parliamentary Committee on Electoral Reforms is already working on re-visiting the electoral laws,

therefore, this Bill may be treated as suggestion from the Member to the Parliamentary Committee.

The Mover did not agree with the suggestion, so after clause by clause consideration of the Bill, the Bill was passed unanimously by the House.

STATEMENT BY THE MINISTER FOR LAW AND JUSTICE

Mr. Zahid Hamid, Minister for Law and Justice categorically stated that the Government has deliberately not pressed the Civil Court (Amendment) Bill, 2016 and a fresh Bill will be introduced after further consultation.

OBSERVATION/DIRECTION OF THE CHAIRMAN

The Chairman directed the Minister for Defence to brief the House on the following issues:-

- ➤ Whether the former Chief of Army Staff has accepted any position in the Saudi lead Military alliance of Islamic States?
- ➤ If yes, what are the rules which govern the acceptance of any position by a retired COAS?
- ➤ Whether such rules were observed by the former COAS while accepting the position?
- ➤ Whether he has availed NOC from the Federal Government, if yes, who issued such NOC?

The Minister confirmed that he will brief the House on the issues on Wednesday, the 11th January, 2017.

The Chairman further directed the Law Minister to ask the Advisor to the Prime Minister on Foreign Affairs to brief the House about the impact of acceptance of such position by former COAS on the Foreign Policy of Pakistan and the stand taken by the Parliament of Pakistan in Joint Sitting.

DISCUSSION ON THE INCIDENT OF DOMESTIC VIOLENCE OF A MINOR GIRL IN ISLAMABAD AND THE ABDUCTION OF FOUR MEMBERS OF CIVIL SOCIETY

After the discussion, the Chairman observed that the case of domestic violence cannot only be attributed to judiciary just because of the reason that a sitting Judge is the accused in the case but the fact of the matter is that such incidents happens in every segment of society for which we are collectively responsible. The Chairman further observed that to meet the ends of justice, the Judges who are involved in the inquiry should be suspended till completion of the enquiry.

- ✓ The Chairman referred the matter incident of domestic violence to the
 Committee on Human Rights.
- ✓ As far as the incidents of abduction of four members of civil society is concerned, the Chairman asked the Leader of the House that the Minister for Interior may be asked to brief the House tomorrow and if any information is to be fetched from the Provincial Government that may also be obtained and the House may be briefed on the circumstances under which the persons were abducted and the steps taken by the Government so far for their recovery.

ZERO HOUR

Senator Sardar Fateh Muhammad Hassani pointed out the hunting of TILOUR in Balochistan by the Arab princes and violations of Baloch traditions by the outsiders. He further pointed out the land grabbing in Balochistan under the supervision of Federal Government which is totally uncalled for and the Tribesmen of Balochistan will not allow such grabbing.

The Chairman directed the Member to move a Calling Attention Notice so that response of the concerned Minister may be obtained.
