Khawaja Muhammad Asif, Minister for Foreign Affairs wound up the debate.

The Chairman while addressing the Prime Minister stated that if the current Session may be extended till next week then the recommendations of the drafting Committee can be debated in the House and after adoption the same can be transmitted to the National Assembly for discussion either in the National Assembly Session or in Joint Session.

The Prime Minister welcomed the recommendations from the Senate and assured that the same will be considered either in the National Assembly Session or in Joint Session.

## MOTIONS [Under Rule 194(1)]

1. **SENATOR DR. JEHANZEB JAMALDINI,** Chairman, Committee on Rules of Procedure and Privileges, moved under sub-rule (1) of rule 194 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the time for presentation of report of the Committee on the question of breach of privilege of the Senate by the Ministry of Finance and National Bank of Pakistan by not acting upon the ruling of the Chairman Senate of dated 4th November, 2016, which was communicated to the concerned quarters vide this Secretariat letter No F. 31(1)/2016-legis on the same day, regarding taking action against the persons /officials of the National Bank of Pakistan and the Ministry of Finance who had drafted and approved the misleading answer to starred question No. 4, set down for answering on 6<sup>th</sup> September, 2016, for placing the same before the Parliament, may be extended for a further period of thirty working days with effect from 5<sup>th</sup> September, 2017.

Motion was put to the house, Chairman suggested the mover to amend it for thirty days instead of sixty. Thereafter, extension was granted for thirty days.

2. Senator Syed Muzafar Hussain Shah on his behalf and on behalf of **SENATOR DR. JEHANZEB JAMALDINI**, Chairman, Committee on Rules of Procedure and Privileges, moved under sub-rule (1) of rule 194 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the time for presentation of report of the Committee on Privilege Motion No. 1(257)/2016-M, moved by Senator Syed Muzafar Hussain Shah, against the Chairman CDA for not implementing the recommendations of the Committee on National Food Security and Research on the matter of proposed conversion of 1400 acres of NARC land by CDA into residential / commercial plots, may be extended for a further period of thirty working days with effect from 2<sup>nd</sup> September, 2017.

Motion was put to the house and extension was granted for thirty days.

SENATOR SYED MUZAFAR HUSSAIN SHAH, Chairman, Standing Committee on National Food Security and Research, presented 16<sup>th</sup> follow up report of the Committee regarding proposed conversion of 1400 acres land of National Agricultural Research Centre (NARC) / Pakistan Agricultural Research Council (PARC) by the Capital Development Authority (CDA) into residential/commercial plots.
