






















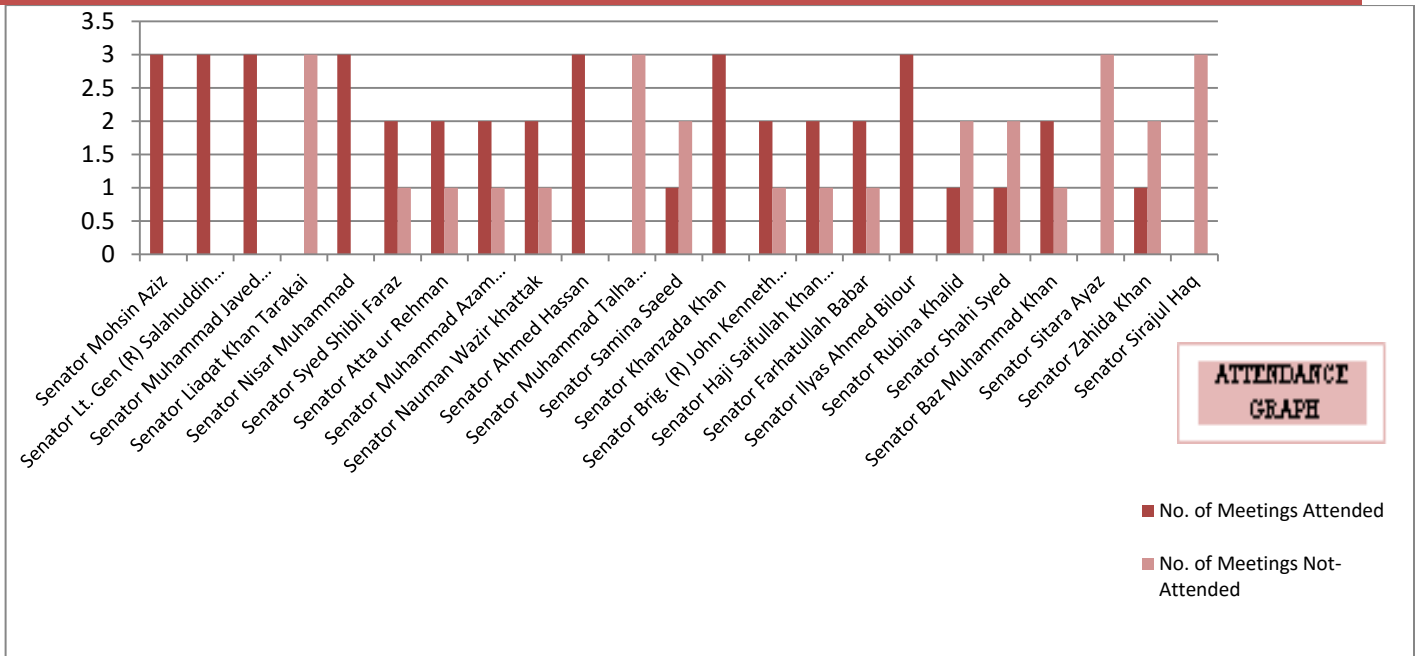

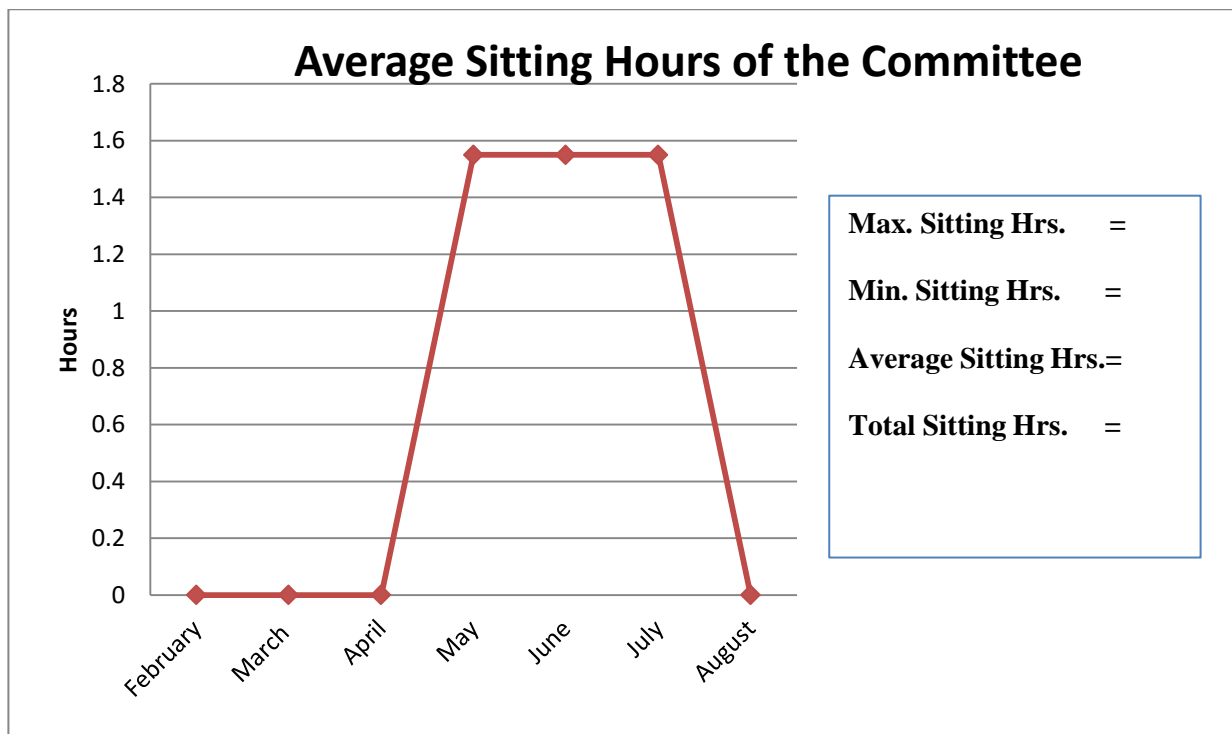

**8. Agenda Items of the Meetings:**

**1) Meeting held on 07-04-2017:**

**Visit of Bacha Khan Airport, Peshawar**

- i. To physically monitor the expansion and renovation work as well as facilities to the passengers at different airport counter.

**Meeting at the Chief Minister's Secretariat, KPK, Peshawar**

- i. Further discussion on the existing condition of Bacha Khan Airport and of its expansion and renovation work.

**2) Meeting held on 10-05-2017:**

- i. Briefing on the existing condition of Bacha Khan Airport and complete details of its expansion and renovation work.

**3) Meeting held on 14-06-2017:**

- i. Implementation status of the recommendations made by special committee during its meeting held on 10-05-2017.
- ii. Further discussion on the existing condition of Bacha Khan Airport, Peshawar and its expansion and renovation work.

**9. Important Recommendations of the Committee:**

**1) Meeting held on 07-04-2017:**

- i. The committee directed that target date being November, 2017 must be observed.
- ii. The committee directed to manage the space in a scientific way and to start work on the multi storied parking immediately.
- iii. The committee directed that the roads linking the airport must be expanded to make it a four lane entry along with the old access roads to the airport.

- iv. The committee also directed CAA to write letter to the concerned departments of provincial government for acquisition of land for creation of additional lanes.
- v. The committee directed that Mall road through Jang road to the Airport be made operational.
- vi. The committee recommended that 2<sup>nd</sup> new international airport for Peshawar as the ongoing expansion cannot suffice beyond five years.
- vii. The committee recommended that flights need to be increased.
- viii. The committee recommended for 2-3 additional immigration counters to reduce waiting time of passengers.
- ix. The committee recommended that number of family members of passengers should be limited.
- x. The committee recommended to stagger the flights with three times charges during peak hours from 6 a.m to 9 a.m.
- xi. The committee recommended that height of the ceiling in passenger lounges must be as per international standers. The committee also directed for installation of extra Air-Conditioners to avoid suffocation.
- xii. The committee also proposed that during the ongoing work a shuttle service may be started from a far off distance where the luggage can be brought separately and the accompanying persons can see off the passengers at the point.

**2) Meeting held on 10-05-2017:**

- i. The committee directed that the CAA should share the details of survey made by them for the expansion of approach road to the Bacha Khan Airport with the Ministry of Defence.
- ii. The committee directed the CAA to write to the Ministry of Defence about the measurement and provision of land for expansion of the approach road to the airport and the possession of vacant plot opposite the airport for making interim arrangement for car parking.
- iii. The committee also directed that the CAA should take up the issue of expansion of approach road and car parking on top priority failing which the ongoing expansion work will prove to be not very helpful in solving the problems being faced by passengers at the airport.
- iv. The committee directed that the CAA should share the details/results of the in-house study being made for selection of the location for new international airport in Peshawar.

**3) Meeting held on 14-06-2017:**

- i. The committee directed that the entry side of the approach road to the Airport should be expanded to 4 lanes from the existing 2 lanes. The exit side of the road may be left with the existing 2 lanes.
- ii. The committee directed that one of the two roads i.e. Khyber road from Aman Chowk to Airport and the Bahadar Yar Jang road should be opened for general traffic with security check posts at suitable places. The committee directed that preference should be given to the opening of Khyber road as the same is the old access road to the Airport.
- iii. The committee directed that the Joint Secretary I (Army), MOD should be focal person for pursuing the case for provision of land to the provincial Government for expansion of the approach road and to the CAA for interim car parking. The

- committee also directed to expedite the said case and provide the land to CAA for interim car parking at the earliest.
- iv. The committee directed that the process including the issuance of tenders for construction of base camp for ASF and construction of new car parking in the airport should be started immediately.
  - v. The committee directed that modern equipment for car checking should be installed in the new car parking to avoid congestion at the entrance of airport.
  - vi. The committee directed that the ongoing work of expansion and renovation at the airport should be completed by November-December 2017. The committee also directed to ensure quality of work in the project.
  - vii. The committee directed that the process of selection of site for new international airport in Peshawar may be expedited. Preference should be given to the Badhber side in order to facilitate the people of Sothern districts of KP as the needs of the northern side of the province will be greatly catered for by the new Islamabad International airport.
