



1) Meeting held on 11.04.2017:

- Confirmation of the minutes of last meeting of the Standing Committee on National Food Security & Research held on 13.02.2017 and latest position of the 1400 acres land of PARC and progress report in the case pending before the Supreme Court of Pakistan.
- ii. Briefing by the Director General, FIA on the FIR pertaining to the corruption in the two projects of Olive cultivation carried out by the Pakistan Agricultural Research Council (PARC) alongwith the progress so far made and investigations conducted by the FIA and findings thereof against the officers allegedly involved.
- iii. Disbursement of agricultural credits by the ZaraiTaraqiaiti Bank Ltd. and scheduled banks for the Kharif, 2017 with district wise breakup.

9. <u>Important Recommendations of the Committee:</u>

1) **Meeting held on 11-04-2017:**

- i. After the detailed briefing by the Additional Director General, FIA Mr. Ahmad Latif, the Chairman and the members of the Committee expressed their satisfaction on the progress of the case and also appreciated the efforts and steps being taken by the FIA in resolving the case. The Chairman further advised the FIA to update the Committee on the progress of the case on regular basis.
- ii. After the briefing by Managing Director, PASSCO and detailed discussion, the hon'able Chairman of the Committee Senator Syed Muzafar Hussain Shah said that, to address all the issues as raised by the Managing Director during the briefing particularly with reference to Sindh province which include procurement of wheat from certain districts as well as non availability of state land for stock of wheat and also difficulties in lifting of such stock, it is necessary to invite the Chief Secretary, Sindh alongwith all concerned in the next meeting of the Committee for resolution of all issues in the best interest of the growers of wheat in Sindh province. The issue of selection and allocation of various centers would also be taken up in the meeting, he further added.
- iii. The matter of Chilli Drying Plant, Kunnri was also discussed in the meeting and Chairman of the Committee after briefing, directed the Project Director to submit the report regarding the process of registration of Company under Act and on other related matters on regular basis.

2) Meeting held on 17-05-2017:

- i. The Committee after detailed discussion and deliberations on the matter pertaining to the procurement of wheat and difficulties being faced by the PASSCO particularly in the Sindh province advised the Chief Secretary, Sindh to furnish the comprehensive updated report into the matter to the Committee immediately.
- ii. Issue the minutes of the meeting held on 05.04.2017 between Managing Director, PASSCO and Chief Secretary, Sindh and other concerned officers of Government of Sindh without further delay and copy of such minutes may also be sent to Secretary of the Senate Committee on National Food Security & Research.
- iii. The Secretary Food, Government of Sindh also advised to communicate the displeasure of entire Committee for non furnishing of report and failure to attend the meeting of the Committee and further advised to ensure his presence in the meeting as and when it required. Non compliance would lead to the action initiated a motion for breach of privilege of Senate Standing Committee on National Food Security & Research under the Rules of the Procedure and Conduct of Business in the Senate, 2012.
- iv. The Committee in relation to the appointments, deputation and absorptions made in the PARC/NARC during the last three years, advised the Chairman PARC to furnish the report on the following points and also brief the Committee in the next meeting:
 - a. Complete details of appointments, deputation and absorption made in the PARC by clearly mention those which were made in violation of Rules and Regulations.
 - b. Procedure adopted while making appointments, deputations and absorptions alongwith the names of appointing authority as well as details of the Selection Committees.
 - c. Actions taken in compliance with the decision/directions of Supreme Court of Pakistan in relation to the illegal appointments and absorptions.
 - d. A complete list of vacant posts in PARC/NARC alongwith the prescribed quota set by the Federal Government.
 - e. Details of those employees who were appointed on a particular projects alongwith the status of the projects and if completed what is the fate of those employees who were appointed.
- v. In view of the inappropriate replies and failing to resolve the administrative issues of the PARC as well as undermining the authority of Parliamentary Committees, the Committee endorsed the viewpoint of Senator Muhammad Azam Khan Swati to recommend the Ministry to reconsider the appointment of Dr. YousufZafar as Chairman PARC.

3) Meeting held on 06-06-2017:

i. During the deliberations of the Standing Committee on agriculture credit, the Committee unanimously felt that taking into consideration the present cost of basic inputs and the inflation which is rampant at present, the Committee was therefore unanimously of the view that in order to equip the small farmers who own atleast 12 and half acre of the land, should atleast be given a minimum credit facility of Rs.250,000/- enabling them to purchase the minimum inputs required for major crops. This may also be communicated to the Finance Committees of the Senate and the National Assembly, the Ministry of Finance and the State Bank of Pakistan.

- ii. On the question of interest rate on agriculture loans, the Committee unanimously of the view that in order to avail the facility of agriculture credit, it is essential that the interest rate should be atleast at par with those which are presently available to the industrial sector and the interest rate at 9.9% as announced in the budget seems to be on higher side and the small farmer may not be able to avail the facility on this interest rate, the committee therefore recommends that interest rate for agriculture credit for small farmers should be at par with the industrial sector.
- iii. The Committee also places on record the sense of appreciation for government of Punjab for initiating interest free scheme on agriculture loans for small farmers.
- iv. The Committee while going through the inquiry report felt that the report is incomplete and lacks reasoning and other details, the Committee therefore requested the Minister for National Food Security & Research to look into it personally and brief the outcome of the inquiry in the next meeting.
- v. The Chairman, PARC is directed to submit a copy of MOU signed between PARC and NTS and also the inquires conducted by them in relation to appointment made in last three years. Also whether the same are made in accordance with the rules or otherwise, if so detail of the inquiry reports should be submitted to the Secretary of the Committee within a week.

4) Meeting held on 18-07-2017:

- i) The Committee while showing its displeasure on delay of resolving the issue of 1400 acres of land leased out to the PARC by CDA and also non implementation of the recommendations of the Committee into the said matter, advised the Chairman CDA to take up this issue with the Cabinet Division and make efforts to get early decision on the summary moved by the CDA and submit report in the next meeting. The Committee also directed the Chairman PARC to request the Registrar Supreme Court for early fixation of the case pending before the apex court into the matter.
 - The Chairman Committee also seek assistance from the Minister, NFS&R for the resolution of said matter in light of the recommendations of the Committee as early as possible.
- ii) The Committee after having discussion on the report of the Sub-Committee constituted under the Convenership of Senator Muhammad Mohsin Khan Leghari asked the Chairman PARC to tender apology alongwith the Officer Incharge, afresh in writing and also in future the schedule of wheat seminar may be issued in consultation with the members of the Committee. Moreover, a directory of the prominent wheat growers of the wheat producing areas of Sindh and Punjab provinces may be compiled which may contain all the details of the each grower. All these growers may also be invited in the mobile wheat seminars, whenever takes place.
- The agenda item in relation to the appointments, deputations and absorptions in the PARC was differed till next meeting with the directions that Chairman PARC and Secretary Committee to sit together and ensure the availability of all relevant documents before the Committee in next meeting.
- iv) After having briefing from the concerned officer of the Textile Ministry on the upto-date position of the cotton crop in Punjab and Sindh as well as attack of Armyworm and Pink Bollworm, the Committee advised the officer to submit an updated report before the next meeting of the Committee.
- v) After the detailed briefing by the Managing Director, PASSCO on the various issues pertaining to the Sindh province in relation to the procurement of wheat and its disposed as well as delay in taking decision of availability of stat land by the Sindh Government

- to PASSCO in some districts, the Committee decided to hold meeting in the office of Chief Secretary Sindh at Karachi in order to resolve this very important issue, after ascertaining the availability of hon'able Federal Minister and Chief Secretary, Sindh.
- vi) The Committee while appreciating the decision of the ZTBL in relation to the constitution of Zonal Committees and including the names of progressive farmers of respective zones as members of Committee. However, the various members of the Senate Committee have observed that in most of the meetings the progressive farmers have not been invited in such meetings, therefore the Committee advised the President, ZTBL to issue directions to all the Zonal Chiefs to hold meetings at least once in every quarter and also ensure the presence of progressive farmers of respective zone in the meetings. A follow up report in this regard may be submitted to the Secretary of the Committee on National Food Security & Research on regular basis.
