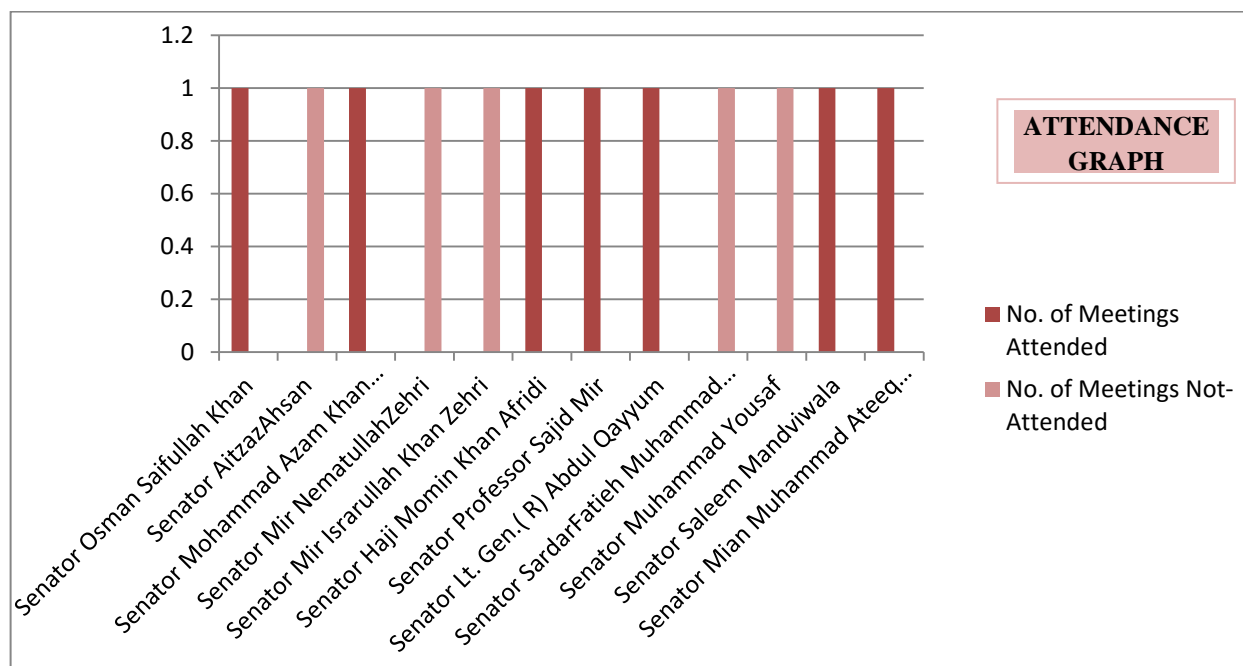

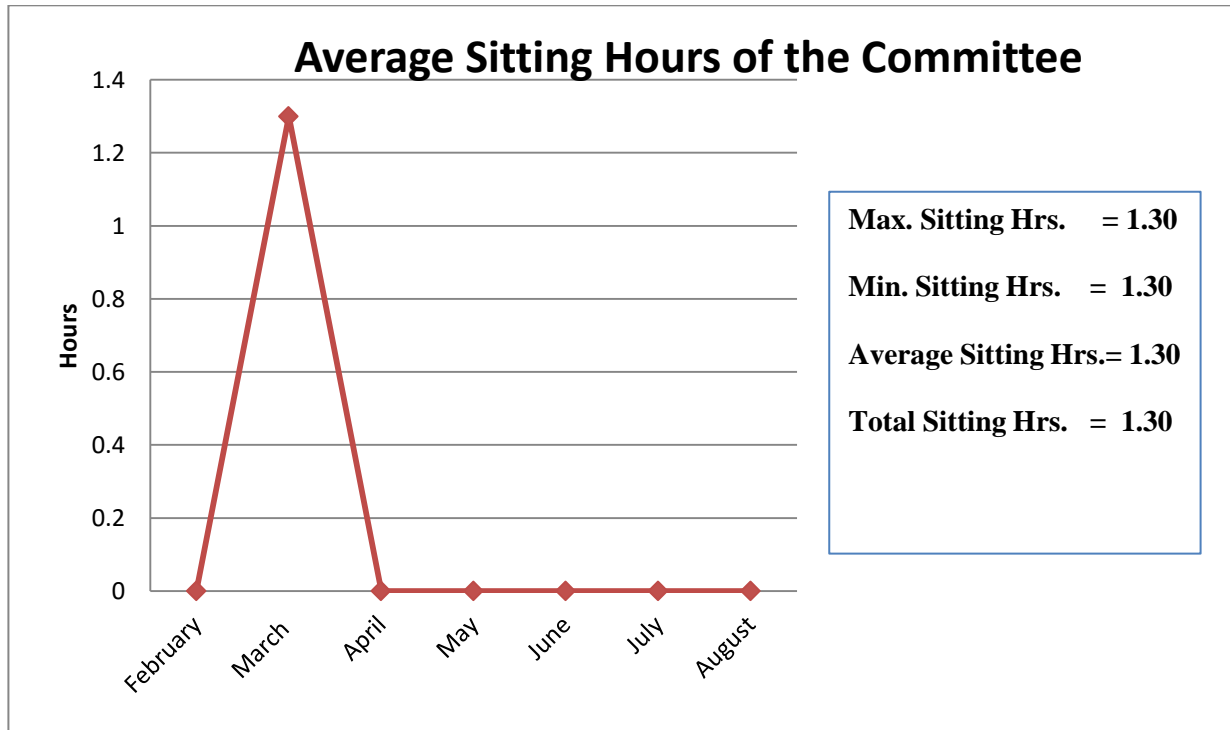

### 1) Meeting held on 02-03-2017:

- i. The committee recommended that HEC should seriously study the efficacy of requiring all faculties and other teaching staff of universities to undergo periodic psychological and psychometric tests.
- ii. The Committee directed Ministry of Science and Technology to ensure that statutes and rules framed after a law is promulgated are strictly in conformity with that law.
- iii. The Committee directed that rules and statutes framed under the COMSATS University Islamabad Bill, 2017 when Promulgated, shall be presented to the Committee.
- iv. The committee directed that in the statutes to be framed later, the Search Committee for appointment of Reactor will be made time bound.
- v. The Committee recommended that the COMSATS University Islamabad Bill, 2017, as reported by the Committee, may be passed by the Senate.
