












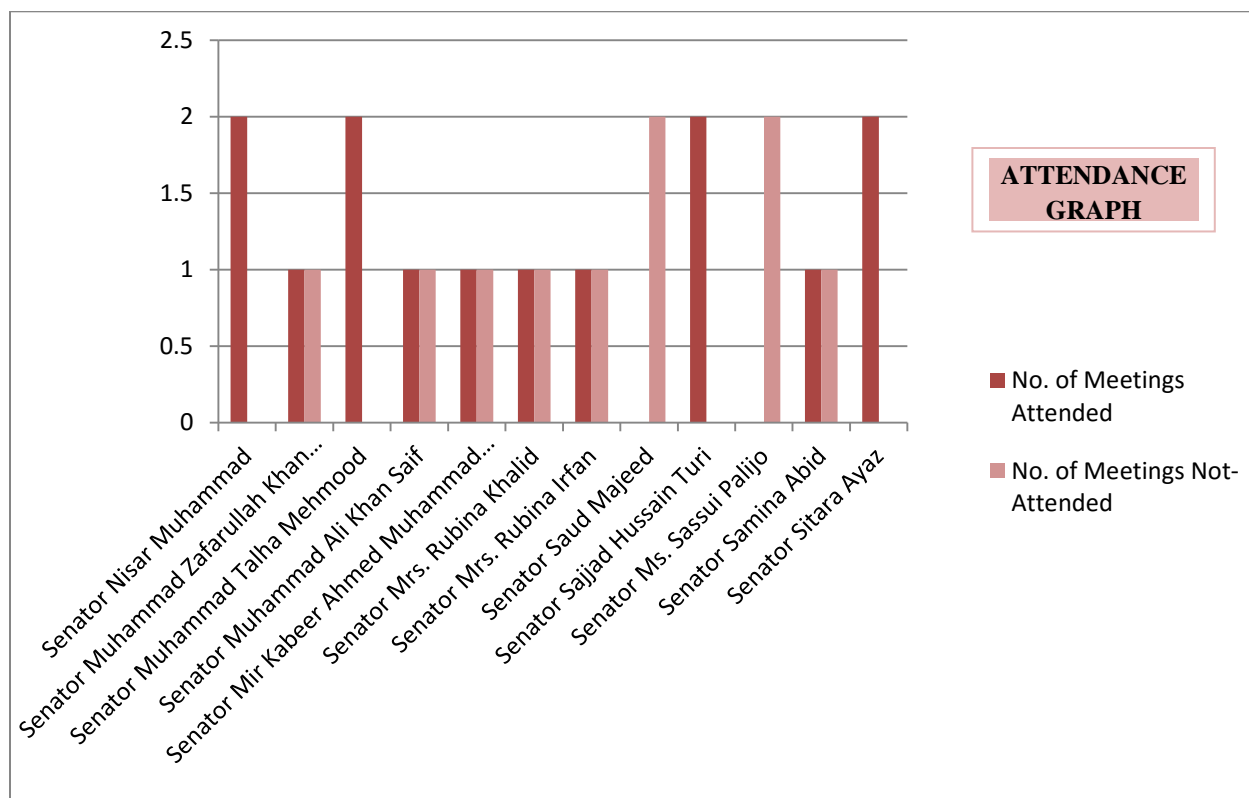

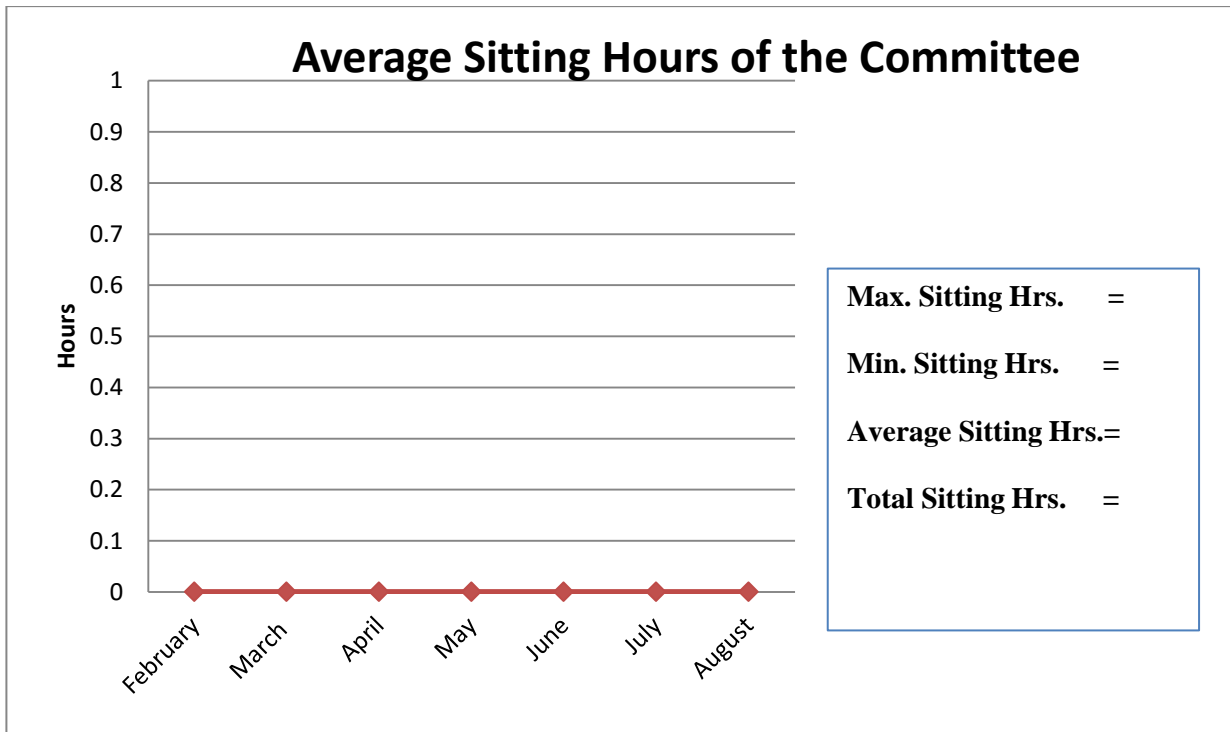

8. Agenda Items of the Meetings:

1) Meeting held on 19-04-2017:

- i. Follow up/compliance reports of the recommendations of the Special Committee in its meeting held on 14th February, 2017.
- ii. Briefing by Chairman NADRA pertaining to the inclusion of Marginalized Segment in the forthcoming census.
- iii. Province-wise break-up along with total amount earmarked/spent on SDGs and MDGs in the financial year 2014-15, 2015-16 and 2016-17.

2) Meeting held on 12-06-2017:

- i. Presentation on District wise poverty profile of the provinces including marginalized groups by the Ministry of Planning and Development.
- ii. The efforts undertaken by the Federal Government in addressing the financial difficulties being confronted by the terrorist effectees as well as families of the terrorist including the detail of total budget allocated and spent for the purpose during the last three years by the Federal Government.

9. Important Recommendations of the Committee:

1) Meeting held on 19-04-2016:

- i. The Secretary Planning and Development of all Provinces along with FATA to be called for the next meeting.
- ii. The representative from Pakistan Bureau of Statistics and Cabinet Division to be called for briefing to the Committee member.
- iii. Ministry of Planning and Development to give presentation on district wise poverty profile of the provinces including marginalized groups.
- iv. Representative of Benazir Income Support Program (BISP) may also be invited in the next meeting.

2) Meeting held on 12-06-2017:

- i. The Committee recommended for the compilation of category wise data of Marginalized Segments in the country.
- ii. The Committee recommended that allocation amongst the Provinces/Districts should be rationalized and must be based upon their respective ratio of poverty so that it is ensured that the Provinces/Districts get the required level of funding necessary to alleviate and reduce poverty.
- iii. The Committee recommended for formulating a mechanism for rationalized and justified resource allocation to these Provinces/Districts for overcoming poverty and direct for building a criterion for the Prime Minister's discretionary allocation/funding in the annual PSDP.
- iv. The Committee greatly urged for enhancing the funding of bomb blast victims and recommended for diverting at least Rs. 5 Billion initially out of the BSIP annual allocating amounting to Rs. 120 Billion.

- v. The Committee recommended for increasing the Financial Assistance for the reconstruction of damaged and partially damaged houses in FATA as a result of terrorist activities.
- vi. The Committee decided to visit to Chitral and Gwadar after Eid.
- vii. The National Commission on Transgender be invited for briefing in the next meeting.
