#### [ZERO HOUR]

1. Senator Sehar Kamran while referring to her bill regarding underage for marriage, which is pending before the Council of Islamic Ideology (CII), presented to Chair, a fatwa by Al-Azhar University on the said matter. Moreover, the senator also showed concern as She is about to retire and the CII has not yet responded on the bill even after the accompanying request asking for a response within a period of three weeks.

Chairman remarked that though Council of Islamic Ideology cannot be bound to respond in stipulated period, however the Senator can ask other members from her party to carry on with the bill.

- 2. Senator Lt. General (R) Abdul Qayyum pointed out the recent Senate elections, in which PML-N candidates could not contest from their party's platform. He highlighted that constitution was silent about period after which a Senator elected from an independent seat has to side with a party.
- **3.** Senator Mukhtiar Ahmed Dhamrah @ Aajiz paid tribute to Mr. Jam Sadiq a veteran politician and his contribution and efforts for democracy and struggle against the dictatorship. Senator Ilyas Ahmad Bilour also paid tribute to Jam Sadiq.
- **4.** Senator Muhammad Usman Khan Kakar expressed concern over the recent horse trading in the Senate elections. Chairman Senate expunged the portion of debate concerning the newly elected Members.
