REPORT OF THE COMMITTEE ON RULES OF PROCEDURE AND PRIVILEGES ON THE BREACH OF PRIVILEGE OF THE SENATOR HAJI SAIFULLAH KHAN BANGASH DUE TO MISBEHAVIOR WITH HIM AND HIS FAMILY DURING THE ARREST OF HIS SON AT CHAMBA HOUSE, LAHORE, BY THE NAB OFFICIALS.

(Report No. 7 of 2015)

I, Chairman of the Committee on Rules of Procedure and Privileges, have the honour to present report of the Committee on breach of privilege of Senator Haji Saifullah Khan Bangash due to misbehavior with him and his family during the arrest of his son at Chamba House, Lahore, by the NAB officials.



The details of the issue before the Committee were that Senator Haji Saifullah Khan Bangash raised the matter in the House stating that the NAB officials misbehaved with him and his family during the arrest of his son at Chamba House, Lahore. The matter was held in order and referred to the Committee for consideration and report.

4. In the first meeting of the Committee, the Chairman NAB did not attend the meeting which was objected by Senator Saeed Ghani. He was of the view that matter was a serious one and the Chairman, NAB should have attended the meeting and apprised the Committee of the position and the steps taken by them in this regard. He proposed to discuss the matter in the presence of the Chairman, NAB. The DG, NAB (Lahore) informed the Committee that the Chairman, NAB was out of country due to which he could not attend the meeting.
5. The matter was again discussed in the second meeting. The Chairman of the Committee stated that misbehavior with Senator Haji Saifullah Khan Bangash was a serious matter. Misbehavior by Government functionaries with the Senators and their family members was not tolerable. He stated that it is the duty of the public servants to maintain dignity and pay respect to the Parliamentarians.
6. The Deputy Chairman NAB stated that they had already conveyed regret to the Senator. However, he apologized from the Senator again. He stated that they were performing unpleasant job as the people object their working during such type of arrests. He agreed that maintaining the honour of Parliamentarians and their families is the duty of all public servants. The Committee was informed that the arrest was made in presence of Senator and the Senator as well as his family was not misbehaved.
7. Senator Zafar Iqbal Jhagra was of the opinion that employees of NAB were well trained and they usually do not raid on houses. Senator Farhatullah Babar proposed that the apology tendered by the NAB authorities may be accepted.

8. The Chairman Committee emphasized upon NAB that sanctity of veil and enclosures should be maintained. He also directed that in such cases the NAB official should deal with the Parliamentarians and their family members decently.

9. The mover as well as the Committee accepted the apology tendered by the NAB authorities. The Committee disposed off the matter and recommended that no further action is required to be taken in the matter.
