- (vi). Briefing by the National Accountability Bureau (NAB) on the progress made on the fraud committed in the NBP's branch in Bangladesh (Monthly progress review by the Committee); and
- (vii). **Briefing by the Privatization Commission on the upcoming privatization transactions along with their updated status.**
