

Briefing by the M/o National Food Security & Research on the matter of corruption in the two projects of Olive cultivation carried out by the Pakistan Agricultural Research Council (PARC) alongwith the details of inquiry conducted by the FIA and its findings against the officers allegedly involved.
  6. Briefing on the variety system of sugarcane in Punjab.
  7. The mechanism of giving subsidy of fertilizer as announced in the budget and whether any outstanding amount of importers is due.
