

REVISED NOTICE

Reference Senate Secretariat's Notice of even number dated 18th April, 2017. The meeting of the Functional Committee on Human Rights scheduled to be held on 28th April, 2017 at 10:30 A.M in Committee Room No. 4, Parliament House, Islamabad will now be held on the same date, time and venue on the following revised agenda:-

- i. Presentation of the report by the National Commission on Human Rights on "The Transgender Persons (Protection of Rights) Bill, 2017" and discussion/deliberation of the Committee on the Bill.
 - ii. Updated position of the case referred by the Committee to National Commission on Human Rights in its meeting held on 2nd March, 2016 of w/o Mir Muhammad Anwar Zehri, for kidnapping of her children.
 - iii. Updated position of the case of the Pakistani Transgender who was killed in the custody of Saudi Police.
 - iv. **Detailed briefing by Ministry of Human Rights on:**
 - a. **Women distress and detention fund established in 1996 more than 46 million was allocated for the fund but not a single penny has been utilized yet.**
 - b. **Women hostels were approved for working women, land was also allotted but construction is not started yet.**
 - c. **Rs. 170 million was allocated for Ministry of Human Rights projects, 150 and 20 million for establishment of Institute of Human Rights, and for establishment of a helpline respectively. Hitherto only 24 million rupees has been released to Ministry of Human Rights as per website of Planning Commissioner. All the remaining amount would lapse on 20th June, 2017 at the end of current fiscal year.**
 - v. **Briefing by the Chief Secretary Balochistan, on the measures taken by the administration, to help the heirs of 19 people died due to rains and flood, in 2015 Shahnourani area despite of announcement for financial assistance vide Letter No. 9115-16/Flood/RB.**
 - vi. Any other agenda item with permission of the Chair.
