

Privilege Motion No. 01(257)/2016-M moved by Senator Syed Muzafar Hussain Shah, Chairman Committee on National Food Security & Research regarding the breach of privilege committed by the Chairman CDA by not implementing the recommendations of that committee on the matter of proposed conversion of 1400 acres of NARC land by the CDA into residential / commercial plots.
 - ii. Breach of privilege of the Senate by the Ministry of Finance and National Bank of Pakistan by not acting upon the ruling of the Chairman Senate of dated 4th November, 2016, which was communicated to the concerned quarters vide this Secretariat letter No F. 31(1)/2016-legis on the same day, regarding taking action against the persons /officials of the National Bank of Pakistan and the Ministry of Finance who had drafted and approved the misleading answer to starred question No. 4, set down for answering on 6th September, 2016, for placing the same before the Parliament
 - iii. Breach of privilege of the Senate by the Secretary, Ministry of Inter-Provincial Coordination, Islamabad, by providing incorrect and incomplete reply to Senate starred question No. 52, asked by Senator Mian Muhammad Ateeq Shaikh, set down for answering on 12th April, 2017.
 - iv. Privilege motion No. 2(262)/2017- M moved by Senator Shahi Syed against Mr. Mohsin Fawad, SHO, Katling district Mardan, who entered in the house of the mover for search and lodge FIR against his brother and nephews for having weapons in spite of valid licenses for the same.
 - v. Breach of privilege of the House by the Secretary Ministry of Defence and Secretary Ministry of Foreign Affairs by referring to each other and not accepting the responsibility of the Calling Attention Notice moved by Senator Farhatullah Babar on 30th May, 2017 regarding the statements of Saudi authorities that the Islamic Military Alliance will not restrict only to terrorist organizations like ISIS and Al-Qaeda but it will also take action against the rebel groups posing threat to any member country, on the request of that country.
 - vi. Any other item with permission of the Chair.
