I, Senator Mushahidullah Khan, Chairman Senate Standing Committee on Inter-Provincial Coordination on behalf of the Committee have the honor to present the report on Starred Question No. 73 asked by Senator Chaudhary Tanvir Khan in the Senate sitting held on 12<sup>th</sup> January, 2017 regarding income and expenditures of Pakistan Cricket Board during the last five years and referred to the Standing Committee on IPC for consideration and report.


3. The Standing Committee discussed the matter in its meetings held on 24<sup>th</sup> February, 4<sup>th</sup> May and 20<sup>th</sup> June 2017 under the Chairmanship of Senator Mushahidullah Khan. The following members attended the meeting held on 20<sup>th</sup> June 2017:-

The Chairman PCB in the meeting of Committee held on 24<sup>th</sup> February, 2017 provided a detailed statement containing details of income and expenditures incurred by PCB under various heads during the last five years. The Mover of the Starred Question however, asked for certain clarifications in writing related to income from TV rights, detailed procedure of its bidding, the audio streaming rights, sponsorship, internet and logo income, rental income, bank deposits, assets disposed of, figures mentioned under the heading "other", employees of the Board, members of BOG of PCB and profit earned from Pakistan Super League (PSL), 2016. The Chairman PCB provided the requisite information on 12<sup>th</sup> March, 2017 which was forwarded to the Mover on 20<sup>th</sup> March, 2017 for perusal.

5. The Committee in its meeting held on 4<sup>th</sup> May, 2017 placed the matter on the agenda of the meeting but could not be discussed due to non-attendance of the Mover. The subsequent meeting scheduled for 23<sup>rd</sup> May, 2017 could not be convened due to lack of quorum and absence of the Mover as well. The Mover also did not attend the meeting of the Committee held on 20<sup>th</sup> June, 2017 but conveyed to the Chairman his satisfaction on the information provided by the PCB regarding income and expenditures of PCB during the last five years. The Committee after deliberations on the matter also expressed satisfaction on the briefing and details of income and expenditures provided by the PCB.

6. The Committee recommends that since the Mover of the Starred Question No. 73 and the Committee has no further quires / reservations about the income and expenditures of PCB during the last five years, the matter may be treated as disposed of.
