

Privilege Motion No. 01(257)/2016-M moved by Senator Syed Muzafar Hussain Shah, Chairman Committee on National Food Security & Research regarding the breach of privilege committed by the Chairman CDA by not implementing the recommendations of that committee on the matter of proposed conversion of 1400 acres of NARC land by the CDA into residential / commercial plots.
 - ii. Discussion on present status of implementation of decisions taken by the committee in its meeting held on 3rd July, 2017, regarding breach of privilege of the Senate by the Ministry of Finance and National Bank of Pakistan by not acting upon the ruling of the Chairman Senate of dated 4th November, 2016, regarding taking action against the persons /officials of the National Bank of Pakistan and the Ministry of Finance who had drafted and approved the misleading answer to starred question No. 4, set down for answering on 6th September, 2016, for placing the same before the Parliament.
 - iii. Amendments in rules 64 and 93 of the Rules of Procedure and Conduct of Business in the Senate, 2012, moved by Senator Karim Ahmed Khawaja on his behalf and on behalf of other members, on 21st August, 2017.
 - iv. Contempt of the standing committee on Finance committed by the Secretary Finance by not providing their views to that committee on the Bill further to amend the Protection of Economic Reforms (Amendment) Bill, 2016, moved by Senator Saleem Mandviwala on 3rd October, 2016.
 - v. Contempt of the House committed by the Additional Secretary (America), Ministry of Foreign Affairs, by not complying with the directives of the Chair to be present in the House during debate on national security issue arising out of US President's new strategy for South Asia and Afghanistan and remarks about Pakistan, which was referred to the committee on 23rd August, 2017.
