REVISED NOTICE

Reference Senate Secretariat's notice of even number, dated 24th August, 2017. A meeting of the Standing Committee on **Finance, Revenue** and Economic Affairs will be held on 7th September, 2017, at 02.30 p.m., in Committee Room No.1, Parliament House, Islamabad.

2. The **revised** agenda before the Committee would be as under:-

- (i). Consideration of Public Petition No.1942, submitted by one Mr. Muhammad Babar Haq, regarding revision of currency carrying limit from Pakistan, referred by the Chairman Senate to the Committee for disposal within thirty working days.
[Note: The disposal of the petition is required i.e. on or before 27th September, 2017]
- (ii). **Ratification of the nomination of Senator Taj Haider as Member of the Policy Board of Federal Board of Revenue (FBR) made by the Chairman Senate;**
- (iii). Briefing by the Finance Division on the alleged double booking of Rs. 64 billion of Pakistan Development Fund Limited (PDFL) as "non-tax revenue" to understate budget deficit;
- (iv). Progress report by the Finance Division on the recommendations made by the Committee to present draft Bill in respect of the Federal Consolidated Fund (FCF) and Public Account as required under Article 79 of the Constitution;
- (v). Compliance report by the Finance Division and House Building Finance Corporation (HBFC) regarding write-off of outstanding loans against 5000 widows;
- (vi). Briefing by the Finance Division on the re-appropriations made during the last financial year along with the relevant rules and authority under which re-appropriations are made;
- (vii). **Discussion on the report of the SECP on the alleged corruption of 17.5 million US \$ in Multan Metro Bus Project;**
- (viii). In-camera briefing by the Finance Division on the total borrowing by the Government with particular reference to the Chinese Banks during the last four years including mark-up rates; and
- (ix). Any other item with permission of the Chair.
