**REVISED NOTICE**

Reference Senate Secretariat's Notice of even number, dated 8<sup>th</sup> September, 2017. A meeting of the Standing Committee on **Finance, Revenue** and Economic Affairs will be held on 13<sup>th</sup> September, 2017, at 02.30 p.m., in Committee Room No.1, Parliament House, Islamabad. **In case of Senate Session in the evening, the meeting will be held at 11.00 a.m.**

2. The **revised** agenda before the Committee would be as under:-

- (i). Consideration of subject matter of an Adjournment Motion moved by Senator Mian Muhammad Ateeq Shaikh on 25<sup>th</sup> August, 2017, regarding the impact of third tier excise duty (FED) on tobacco products which is a violation of WHO's Framework Convention of Tobacco Control (FCTC) on one hand and would result into increase in Tobacco consumption on the other hand, and referred to the Committee for consideration and report;

- (ii). Briefing by the Federal Board of Revenue (FBR) on the difficulties being faced by importers on the import of solar power generator systems along with the details of exemption given to solar systems;
- (iii). Briefing by the Auditor General of Pakistan (AGP) on the financial embezzlement/irregularities and overpayment worth of Rs.382 billion found in different public sector entities of the federal ministries during 2016-17;
- (iv). **Discussion on the report of the SECP on the alleged corruption of 17.5 million US \$ in Multan Metro Bus Project;**
- (v). In-camera briefing by the Finance Division on the role of private banks i.e. Standard Chartered Bank, Citi Bank and Deutsche Bank regarding issuance of Euro Bonds by the Government of Pakistan; and
- (vi). Any other item with permission of the Chair.
