Further discussion with the FBR on the recent imposition/increase of the regulatory duties on imported items with particular reference to All Pakistan Textile Mills Association (APTMA), Pakistan Tyre Importers & Dealers Association (PTIDA), Pakistan Chemicals & Dyes Merchants Association and Thal Engineering;
- (v). In-camera briefing by the Finance Division and the Standard Chartered Bank, the Citi Bank and the Deutshce Bank on the issuance of \$500 million Euro Bonds in the year 2015; and
