

A meeting of the Committee on Rules of Procedure and Privileges will be held on 2nd January, 2017, at 11:00 a.m. in Committee Room No. 4, Parliament House, Islamabad.

2. The agenda before the Committee would be as under:-
- i. Breach of privilege of the Chairman Senate when he was acting as President and visited Karachi on 17th September, 2017, by the Chief Secretary, Sindh, I.G. Sindh, Commissioner Karachi and Deputy Commissioner, Malir, Karachi by not receiving the Acting President at Karachi Airport and non-provision of Protocol to him according to blue book.
 - ii. Privilege motion 1(268-2017)-M, moved by Senator Muhammad Azam Khan Swati, regarding non-provision of relevant documents relating to development work carried out in NA-21 since 2013 by Pak-PWD, Hazara Division, asked for by the mover.
 - iii. Privilege motion 1(269-2017)-M, moved by Senator Syed Muzafar Hussain Shah, regarding non-provision of reports by the PIA management to the Senate Special Committee on the Performance of PIA, pertaining to the following incidents:
 - i. The alleged seizure of heroin at the Heathrow Airport London from PIA flight;
 - ii. The matter wherein a lady was invited by the PIA pilot to the cockpit on 6-5-2017 compromises the safety of the passengers; and
 - iii. The matter wherein a senior pilot had gone to sleep during the PIA Flight PK-785 compromises the safety of the passengers on 26.4. 2017.
 - iv. Privilege motion 2(269-2017)-M, moved by Senator Syed Muzafar Hussain Shah, regarding non-implementation of the recommendations of Sub Committee on the Performance of PIA, by the Aviation Division, after the lapse of seven months, which were adopted by the House on 16.3.2017.
 - v. Breach of privilege of the House due to inappropriate reply by the Joint Secretary, Ministry of Interior, in response to a calling attention notice moved by Senators Dr. Jehanzeb Jamaldini, Farhatullah Babar, Muhammad Usman Khan Kakar and Sardar Muhammad Azam Khan Musakhel, which was set down for the sitting of the Senate held on 1st November, 2017.
 - vi. Breach of privilege of the House by Mr. Rashid Sultan, Legal Consultant, Petroleum Division, who drafted the Bill and made proposal that the Government may by notification provide that until the authority is constituted and the officers, employees, consultants etc. are appointed under the Act, the powers and functions of the authority shall be exercised and performed by the Director General of Petroleum concessions.
 - vii. Any other item with permission of the Chair.
