The Committee considered and discussed the subject matter of point raised by Senator Samina Saeed regarding ATR Plane crashed during the flight from Chitral to Islamabad" in detail in its meeting held on 17<sup>th</sup> January, 2018. 



4. During the meeting the Senator Samina Saeed, Mover of the issued briefed the committee that a number of scandals regarding corruption, smuggling and other issues have been highlighted in the media over the past few years. She added that the condition of planes received from Vietnam was the worst, drugs were recovered from PIA planes, and one of the pilots was criticized for taking pictures in the cockpit. She said it has been 13 months and the report of the PIA plane accident is yet to be made public. Some relatives of the victims of the Havelian crash, including the family of first officer Ahmed Janjua, have not yet received compensation or the insurance sum.

5. Secretary, CAA said that heirs of each victim of crashed plane were paid Rs.5 million each and that insurance and the brother of pilot is appointed as pilot. He committed that in this regard a written report will be submitted within ten days. He further briefed the Committee that one of the engines had failed and the propeller had also been out of order.

6. After discussion in detail, Committee directed to Secretary CAA, that comprehensive report with regard to payment of compensation to families of victims of the crash and clearance report signed by technical engineer is to be submitted to the Committee within ten days, hence the agenda item was disposed off for report back to the House with the consent of Mover.
