Consideration and adoption of report of the Committee on breach of privilege of the House by Mr. Rashid Sultan, Legal Consultant, Petroleum Division, who drafted the Bill and made proposal that the Government may by notification provide that until the authority is constituted and the officers, employees, consultants etc. are appointed under the Act, the powers and functions of the authority shall be exercised and performed by the Director General of Petroleum concessions.
  - v. Privilege motion 1(268-2017)-M, moved by Senator Muhammad Azam Khan Swati, regarding non-provision of relevant documents relating to development work carried out in NA-21 since 2013 by Pak-PWD, Hazara Division, asked for by the mover.
  - vi. Breach of privilege of the Special Committee on the performance of PIA by the Secretary Aviation Division and Chief Executive Officer, PIA, by not giving response to the Committee on a petition referred by the Chairman Senate to the Committee for consideration and report despite a number of reminders to them by the Secretary Committee.
