The Minister for Planning, Development and Reforms gave a detailed briefing to the Committee regarding completion of western route of CPEC and informed that there was a big gap due to non-existence of connectivity of Gawadar and Quetta which was only lying in the map, however, the western rout had now been completed and fully operational. With regard to the developments made in result of western rout, the Minister for Planning, Development and Reforms said that various developments were took place in Gawadar due to construction of western rout in respect of agriculture, educational institutions, hospitals and transportation etc. He said that a 300 M.W. power plant, new airport and resorts of coastal terrorism would also be constructed within two to four years and funding would also be provided by the Federal Government. He said the assurance given by him was now fulfilled and the western rout had now been fully operational since November, 2016.
- 5. The Committee showed its satisfaction on the fulfillment of the assurance, given by the Minister for Planning, Development and Reforms regarding completion of western route of CPEC by December, 2016, and disposed of the issue.
