REPORT OF THE COMMITTEE ON PRIVILEGE MOTION 1(269-2017)-M, MOVED BY SENATOR SYED MUZAFAR HUSSAIN SHAH, REGARDING NON-PROVISION OF REPORTS BY THE PIA MANAGEMENT TO THE SENATE SPECIAL COMMITTEE ON THE PERFORMANCE OF PIA, PERTAINING TO THE FOLLOWING INCIDENTS:

- i. THE ALLEGED SEIZURE OF HEROIN AT THE HEATHROW AIRPORT LONDON FROM PIA FLIGHT;
- ii. THE MATTER WHEREIN A LADY WAS INVITED BY THE PIA PILOT TO THE COCKPIT ON 6-5-2017 COMPROMISES THE SAFETY OF THE PASSENGERS; AND
- iii. THE MATTER WHEREIN A SENIOR PILOT HAD GONE TO SLEEP DURING THE PIA FLIGHT PK-785 COMPROMISES THE SAFETY OF THE PASSENGERS ON 26.4. 2017.

- I, Chairman of the Committee on Rules of Procedure and Privileges, have the honour to present report of the Committee on Privilege motion 1(269)/2017-M, moved by Senator Syed Muzafar Hussain Shah, regarding non-provision of reports by the PIA management to the Senate Special Committee on the Performance of PIA, pertaining to the following incidents:
 - (i) The alleged seizure of heroin at Heathrow Airport London from PIA flight;
 - (ii) The matter wherein a lady was invited by the PIA pilot to the cockpit on 6-5-2017 compromising the safety of the passengers; and
 - (iii) The matter wherein a senior pilot had gone to sleep during the PIA Flight PK-785 compromising the safety of the passengers on 26.4. 2017.

3. The details of the matter before the committee were that Senator Syed Muzafar Hussain Shah moved motion 1(269)/2017-M, regarding non-provision of the said reports by

the PIA management to the Senate Special Committee on the Performance of PIA. The Honourable Chairman held the motion in order and referred the same to the Committee on Rules of Procedure and Privileges for investigation and report. The committee discussed the matter in its meetings held on 24th November, 2017, 2nd January and 19th and 26th February, 2018. The concerned officers of Aviation Division and PIA authorities were summoned to appear before the committee and give the explanation in the matter.

- 4. The Aviation Division informed through working papers that the Secretary, Senate Special Committee on the Performance of PIA, sought report on the said three points vide a letter of dated 30th May, 2017. They sent the report on first point to the committee. Regarding the remaining two points, they informed that they sent a brief to the committee containing information on those points through a letter on dated 5th July, 2017.
- 5. The committee showed concerns on the attitude of the Government functionaries in providing information asked for by the Parliament and its committees. It directed that the information asked for and directions issued by the Parliament and its committees should be complied with in true letter and spirit.
- 6. Senator Syed Muzaffar Hussain Shah, mover of the privilege motion, sent a communication to the Chairman committee stating therein that he was satisfied over the actions taken by the Civil Aviation and PIA on the said three incidents and did not intend to pursue the matter further.
- 7. In view of not pressing by the mover, the committee disposed off the motion with the recommendation that the House may also disposed it off accordingly.
