

## **SENATE SECRETARIAT ORDERS OF THE DAY**

### **LEGISLATIVE BUSINESS**

2. **SENATOR MIAN MUHAMMAD ATEEQ SHAIKH** to move that the Bill to amend the National Disaster Management Act, 2010 [The National Disaster Management (Amendment) Bill, 2017], as reported by the Committee, be taken into consideration, at once.

3. **SENATOR MIAN MUHAMMAD ATEEQ SHAIKH** to move that the Bill to amend the National Disaster Management Act, 2010 [The National Disaster Management (Amendment) Bill, 2017] be passed.

### **MOTION** (Under Rule 172A)

4. **SENATOR SHERRY REHMAN**, Leader of the Opposition, to move under rule 172A of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the House may constitute itself into a Committee of the Whole to deliberate upon the urgent issues relating to safe and secure conduct of General Elections, 2018 and to ensure that it is free, fair and transparent.

### **MOTIONS** [Under Rule 218]

5. **SENATOR CHAUDHARY TANVIR KHAN** to move that this House may discuss the performance of Pakistan Post and the need and importance of improvement in the same.

6. **SENATOR MIAN MUHAMMAD ATEEQ SHAIKH** to move that this House may discuss the need to expedite work on the projects for construction of small dams and water reservoirs in the country.

7. **SENATOR SYED SHIBLI FARAZ** to move that the House may discuss the performance of Higher Education Commission with particular reference to the impacts of its policies towards the improvement of standards of higher education in the country.

8. **SENATOR LT. GEN. (RETD.) ABDUL QAYYUM** to move that this House may discuss the violations of human rights in Indian occupied Kashmir by the Indian security forces as reported by the United Nations Human Rights Commission in its report on "the status of human rights in the valley of Kashmir" issued in June, 2018.

9. **SENATOR MUHAMMAD TALHA MEHMOOD** to move that the House may discuss the Education Policy of the Government with particular reference to implementation of Article 25A of the Constitution.
