3. The subject Bill was taken up for consideration in the Committee meetings held on 14<sup>th</sup>, 17<sup>th</sup> September, 24<sup>th</sup> October, 21<sup>st</sup> November, 6<sup>th</sup> December, 2017 and 1<sup>st</sup> June, 2018.

The Secretary, Capital Administration and Development Division (CADD) briefed the Committee that Supreme Court of Pakistan has issued an order, wherein the Administration of Gun and Country Club, Islamabad has been transferred to Pakistan Sports complex, which comes within the ambit of Inter Provincial Coordination Division. He suggested that the subject Bill may be referred to concerned Committee for further consideration, because the Administration of Club has been transferred to other Ministry/Division.
