REPORT OF THE STANDING COMMITTEE ON FINANCE, REVENUE AND ECONOMIC AFFAIRS ON THE MONEY/FINANCE SUPPLEMENTARY (AMENDMENT) BILL, 2018

I, Senator Farooq Hamid Naek, Chairman Standing Committee on Finance, Revenue and Economic Affairs, have the honour to submit, on behalf of the Committee, this report on a Money/Finance Supplementary (Amendment) Bill, 2018, laid by the Minister for Finance, Revenue and Economic Affairs in the House on 18th September, 2018, under Article 73 of the Constitution for making recommendations thereon to the National Assembly, and referred to the Committee for consideration and report.

5. The proposals received from the members were referred by the House to the Standing Committee on Finance, Revenue and Economic Affairs for consideration and report.

6. The following recommendations submitted by Senators Siraj ul Haq, Mushtaq Ahmed Khan and Mohsin Aziz were considered and rejected by the Committee unanimously:-

Senators Siraj ul Haq and Mushtaq Ahmed Khan

- (i). In clause (2) of the Bill, the proposed amendments in the Fifth Schedule of Custom Act, 1969, shall be omitted;
- (ii). In clause (3) of the Bill, the proposed amendments in the Sixth Schedule of Sales Tax Act, 1990, shall be omitted; and
- (iii). In clause (4) of the Bill, the proposed amendments in sub-clause (3) shall be omitted.

Mushtaq

Senator Mohsin Aziz

- (i). The Senate of Pakistan recommends to the National Assembly that the export of lead should be excluded from the regulatory duty with the recommendation that amending SRO 645(1)2018 dated 24-05-2018 be withdrawn by restoring the proviso to regulatory duty SRO594(I)2009 dated 25-06-2018 as per proviso added vide SRO983(1)2012 dated 03-08-2012.
- (ii). The Senate of Pakistan recommends to the National Assembly that the exemption under section 126(L) be extended for another three to five years which will ensure industrial betterment in KPK/Baluchistan and to compete fairly with the other parts of Pakistan.

7. The Committee considered the said Bill clause by clause. Senators Musadik Masood Malik and Haroon Khan expressed their serious reservations on the proposed custom duty for the items mentioned in clause 2, sub-clause (3) of the said Bill as well as the criteria for selection of the items. They inquired that what would be the revenue as well as benefit impact to the exports as a result of the proposed custom duty slabs? The Member, National Tariff Commission, M/o Commerce responded that the figures related to the revenue impact could be presented to the Committee, if so desired, however, the provision of figures regarding benefit to the exports were not possible.

8. Senator Musadik Masood Malik objected that the representative of the M/o Commerce stated before the Committee that they had the numbers for cost as well as benefits of the listed items and then retracted on that numbers. Secondly they further stated that the numbers for the components of exports for every item were available with them and then again retracted on the export numbers. He was of the view that making a representation to the Senate Standing Committee and then retracting the same was highly irregular. At that juncture, Senator Haroon Khan supported the objection raised by Senator Musadik Masood Malik and was of the view that the custom officers did not seem to be in agreement with the analysis exercised by the M/o Commerce that the proposed duties would be going to impact the exports positively. He suggested that an exercise for further refinement of the proposed duties should be carried out by the M/o Commerce.

Remark

9. Senator Mohsin Aziz was of the view that there was no retraction as far as the M/o Commerce was concerned and also at the same time the Minister of State for Revenue categorically reinstated during the last Committee meeting that it was not only the export for which those items were under consideration but also the domestic and in the import substitution industry as well as to quantify them in very precise words, it was rather impossible, we could only had an estimated figure that might come into place at the end of the year. At the same time that was exactly according to the principle of WTO in which the cascading formula had to be adopted, meaning thereby the raw material, intermediary goods and finished goods/products, the raw material had to be on the lower side and that was the first step in the right direction. Therefore, the sub-clause (3) of clause 2, as proposed in the said Bill shall be adopted.

10. After detailed deliberations, the Standing Committee proposed the following amendments in the Money/Finance Supplementary (Amendment) Bill, 2018 and a general recommendation:-

PROPOSED AMENDMENTS

- (1) that in clause 1, in sub-clause (2), the words **“unless otherwise provided in any of the provisions of this Act”**, shall be deleted.

Note: Amendment was adopted by majority as Senators Musadik Masood Malik, Haroon Khan, Muhammad Talha Mahmood voted in favour of the amendment while Senators Mohsin Aziz and Mian Muhammad Ateeq Shaik voted against the amendment.

- (2) that in clause 2, sub-clause (3), shall be omitted.

Note: Amendment was adopted by majority as Senators Musadik Masood Malik, Haroon Khan and Muhammad Akram voted in favour of omission of clause 2, sub-clause (3) of the proposed Bill while Senators Mohsin Aziz and Mian Muhammad Ateeq Shaikh voted in favour of that clause.


GENERAL RECOMMENDATION

The Finance Supplementary (Amendment) Bill (Budget) 2018-19 was presented in the National Assembly on 18th September, 2018, by Mr. Asad Umer, Minister for Finance. On the same day a copy of the Finance Bill, containing the Annual Budget Statement was laid in the Senate. On the Motion moved by the Minister for Finance, the Senate was asked to make recommendations, under Article 73 of the Constitution, to the National Assembly in respect of the said Bill, containing the Annual Budget Statement.

2. The Senate Secretariat invited proposals from the Members so as to reach by Friday, the 21st September, 2018. The proposals received were referred to the Standing Committee on Planning, Development and Reforms, for consideration and report.

3. The Standing Committee on Planning, Development and Reforms held its four meetings on 24th, 25th and 26th September, 2018, respectively and recommendations of each Senator were considered and deliberated upon. After detailed deliberations spanning over 7 hours, the Committee finalized 23 recommendations for onward transmission to the Senate Standing Committee on Finance.

1. The Senate recommends to the National Assembly of Pakistan that funds may be allocated for water storage, irrigation, agriculture, power, roads/ highways, new schools and type D hospitals at Khyber Agency Bara.

2. The Senate recommends to the National Assembly of Pakistan that criteria be revised and rules be relaxed in order to increase the number of beneficiaries and funding under the Benazir Income Support Programme (BISP) for Tharparkar District due to drought situation there.

3. The Senate recommends to the National Assembly of Pakistan that due to the deplorable circumstances for fishermen at the Gwadar East Bay, the repeatedly promised funds and development of fishlanding jetty of the West Bay may be completed to end the suffering of the local population.

1. The Senate recommends to the National Assembly of Pakistan that funds may be allocated for Districts Mastung and Khuzdar, which are ideal for harnessing wind and solar energy, so as to meet the energy needs of the country.

- (6) The Senate of Pakistan recommends to the National Assembly that criteria be revised and rules be relaxed in order to increase the number of beneficiaries and funding under the Benazir Income Support Programme (BISP) for Tharparkar District due to drought situation there.
- (7) The Senate of Pakistan recommends to the National Assembly that due to the deplorable circumstances for fishermen at the Gwadar East Bay, the repeatedly promised funds and development of fishlanding jetty of the West Bay may be completed to end the suffering of the local population.
- (8) The Senate of Pakistan recommends to the National Assembly that funds may be allocated for Districts Mastung and Khuzdar, which are ideal for harnessing wind and solar energy, so as to meet the energy needs of the country.
- (9) The Senate of Pakistan recommends to the National Assembly that Supply and installation of Electric Poles and Transformers in Municipal Corporation in District Khuzdar, may be completed on priority
- (10) The Senate of Pakistan recommends to the National Assembly to include the Khawazai and Bazai 132 KVA Grid Station at Mohamand Agency costing Rs. 700 to 800 million in the PSDP 2018-2019 as the same power grid station is urgently needed for the above two Tehsils.



- (11) The Senate of Pakistan recommends to the National Assembly that Bosaq (District Bajour) hydle power station which was reflected in 2018-2019 PSDP, may be expedited.
- (12) The Senate of Pakistan recommends to the National Assembly that irrigation water in particular should be measured by using water meters, and funds be allocated for quantifying and measuring the amount of water.
- (13) The Senate of Pakistan recommends to the National Assembly that in order to reduce drought severity in District Khuzdar, Balochistan, which is expected to be worse with every passing day, small dams need to be constructed on priority.
- (14) The Senate of Pakistan recommends to the National Assembly that following the examples from China, Holland, India, etc, projects for preventing water evaporation by covering canal systems with preferably solar panels to achieve energy generation as well, may be incorporated and approved.
- (15) The Senate of Pakistan recommends to the National Assembly that Government needs to convert the almost 30,000 existing irrigation tube wells to solar.
- (16) The Senate of Pakistan recommends to the National Assembly that owners of the solar powered irrigation system may be bound to use drip/ sprinkler systems only through required legislation.
- (17) The Senate of Pakistan recommends to the National Assembly that toll plazas at N85 and part of M8 to be considered on priority.
- (18) The Senate of Pakistan recommends to the National Assembly that M8 (Motorway) of Khuzdar- Ratodero may be completed on priority.
- (19) The Senate of Pakistan recommends to the National Assembly that completion of Bajaur to Jandola road, which will connect the whole of Tribal districts of KPK (former FATA), as reflected in previous PSDP, may be ensured.



- (20) The Senate of Pakistan recommends to the National Assembly that Bajaur Medical College which was already reflected in FATA A.D.F, with announced vacancies of Project Director and others, may be materialized through allocation of funds.
- (21) The Senate of Pakistan recommends to the National Assembly that a Medical University be established in Hub (near Karachi) and qualified staff, technicians, and teachers/faculty may be hired as permanent/visiting faculty.
- (22) The Senate of Pakistan recommends to the National Assembly that Muhammad Omar Khan Sanjrani Minerals & Natural Resources University be established in Nokkundi, Chagai.
- (23) The Senate of Pakistan recommends to the National Assembly that Gwadar University, as approved and passed by Balochistan Assembly, and being put on hold, may be expedited instead along with release of funds.
- (24) The Senate of Pakistan recommends to the National Assembly that since no progress has been made on the approved Muslim Bagh IT University campus, funds may be released and the project may be expedited towards completion.
- (25) The Senate of Pakistan recommends to the National Assembly that a Cardiac Center in Balochistan may be established on priority to cater to the needs of over 6000 cardiac patients annually in the region.
- (26) The Senate of Pakistan recommends to the National Assembly that a 50 bedded Hospital at Yakmach, Chagai may be established on priority to cater to the needs of patients in the region.
- (27) The Senate of Pakistan recommends to the National Assembly to include angiography lab/electrophysiology procedures for civilian patients at Armed Forces Institute of Cardiology and National Institute of Heart diseases, Rawalpindi, costing Rs.215.400 million in the PSDP 2018-2019.
