SUMMARY

The Ministry informed that Mr.Faisal Hilal (Assistant Director Statistics BS-17) belonging to Baluchistan is working on deputation basis since 20th December, 2017 in Marine Fisheries Department(MFD), Karachi, Ministry of Maritime Affairs.

The Committee showed concern that only a single officer is from Baluchistan and that too, on deputation. It was briefed by the Ministry that there is difference in promotional appointments and direct recruitment. Quota rules apply to both the categories in different way.

RECOMMENDATION

The Committee directed that quota allocated to Baluchistan as per rules, must be observed. The Committee also directed to submit a report in detail about the quota rules and observance to that effect by the Ministry. Also, it was decided that the Ministry will provide details of domiciles.
