After the detailed statement by the CAA and queries made by the Mover, Chairman and other members of the Committee, the Director General (CAA), informed the Committee that the Pakistan Civil Aviation Authority has already established a campus area network at Islamabad International Airport (IIAP) and installed an EPABX with 10,000 lines to cater the operational requirements of PCAA as well as all the stake holders working at the airport, however, presently Public Telephone facility is not available at IIAP. The Secretary Aviation however, assured the Committee that mobile phone facility will be provided within week positively.

Recommendations:-

The Committee, after the detailed briefing by the Director General, CAA and assurance given by the Secretary Aviation regarding the immediate provision of mobile phone facility till the time the normal PABX system is fully operational, the matter was disposed-off after taking consent of the Mover Senator Nighat Mirza. The Committee also advised the CAA to make arrangements for installation/provision of a UAN number.
