### REPORT ON THE MATTER OF THE POINT OF PUBLIC IMPORTANCE REGARDING ABDUCTION OF 13 YEARS OLD GIRL HAROON BIBI D/O ABDULLAH JAN FROM SARGODHA AND NON RESPONSE OF THE POLICE, RAISED BY SENATOR MUHAMMAD USMAN KHANKAKAR IN THE HOUSE ON 09-11.2018.

I, Chairman, Senate Standing Committee on Interior, have the Honour to present report on the matter of the "Point Of Public Importance regarding Abduction of 13 Years Old Girl Haroon Bibi D/O Abdullah Jan from Sargodha and Non Response of The Police, raised by Senator Muhammad Usman Khan Kakar in the House on 09-11.2018.

2. The Point of Public Importance regarding Abduction of 13 years old Girl, Haroon Bibi D/O Abdullah Jan from Sargodha and Non-Response of the Police was raised by Senator Muhammad Usman Khan Kakar in the House on 09-11-2018. The House referred the matter to Senate Standing Committee on Interior for consideration and report back to the House.

6. Senator Muhammad Usman Khan Kakar briefed the Committee on the matter of the abduction of 13 years old girl, Haroon Bibi D/O Abdullah Jan from Sargodha.

7. The father of the missing girl was also present in the meeting and stated that he lodged the complaint of the incident in the Police Station of Atta Shaheed, Sargodha on 30<sup>th</sup> September, 2018. He further stated that the police was co-operating with him but failed to trace out the missing girl.

8. The police informed that they had started the investigation of the missing girl immediately after receiving the complaint. The Investigation Officer visited the spot, prepared a site plan and recorded statements of some persons.

9. The SHO along-with police party carried out a search for the recovery of the missing girl in the vicinity but no clue was found. They also used sniffer dogs for search in the cattle shed of Muhammad Sharif adjacent to the house of the complainant. The CDRs of the mobile phones and Geo-Fencing of the accused persons were also obtained. But, unfortunately, the missing girl is yet to be recovered. The Police assured the Committee that all available sources will be utilized for the recovery of the missing


10. The Chairman Committee directed that the Police should complete the Investigation within four weeks.

11. The Chairman Committee directed that the Police should utilize its all available sources for recovery of Haroon Bibi.

12. The Chairman Committee directed the Ministry of Interior to co-ordinate with the police to take up the matter of the missing girl, Haroon Bibi with all border agencies for identification of the possible presence in the container which was recently reported found trafficking of kids across Pakistani borders.

13. The Chairman Committee, after issuance of the directions to all concerned government departments, disposed of the matter accordingly.
