I, Senator Mian Muhammad Ateeq Shaikh, Chairman, Senate Standing Committee on National Health Services, Regulations & Coordination, have the honour to submit, on behalf of the Committee, this report on the Point of Public Importance raised by Senator Muhammad Usman Khan Kakar in the Senate, regarding misbehave of Executive Director, PIMS, Islamabad, referred by the House on 24-01-2019 to the Committee for consideration and report.

3. The Point of Public Importance was placed on the agenda of the meetings held on 22-02-2019 and 21-03-2019. However, due to absence of the Minister and absence of the Mover of the agenda in the meetings held on 22-02-2019 and 21-03-2019 respectively, the discussion was not made on it.

3A. The matter was related to the misbehave of E.D.PIMS with Dr. Mutahir Shah, Assistant Director BPS-18. According to the Ministerial response submitted in the committee in its meeting held on 02 May, 2019, Dr. Mutahir Shah had misbehaved with E.D.PIMS on the matter of counter signatures on his ACR personally on 02-01-2019. Consequently a disciplinary action was taken against him under the E&D Rules 1973, but later on the matter was amicably resolved and reconciliation took place within the premises of PIMS on 06-02-2019. The committee was informed about all these details in the meeting held on that day.



4. Since conclusive discussion could not be held on the agenda item within 60 days of being referred from the House, the extension of 60 working days was solicited from the Chairman Senate and subsequently the matter was again brought on agenda in Committee meeting held on 02<sup>nd</sup> May, 2019, which was attended by the following:

Senator Usman Khan Kakar, the mover of the Point of Public Importance has satisfied with reply from the Ministry of National Health Service, Regulations & Coordination as well as the position explained by the Executive Director PIMS. The committee assured Senator Usman Khan Kakar that that no discrimination shall be made in the promotion cases of staff members belonging to the less developed areas of the government.
