6. The SP Investigation of Police Station Cantt. Abbottabad briefed the Committee on the action taken regarding murder of Afzal Kohistani. He informed the Committee that the case was referred to Sub Inspector Sher Dil who along with his team visited the spot of the incident. The SHO handed over the accused and recovered 30 Bore pistol from him. The investigation team recorded statements of three injured persons, namely, Kaleem Ullah, Saeed Karim and Sabir Hussian. Kaleem Ullah, one of the injured, identified and charged the arrested accused Faiz-ur-Rehman. The police also collected video footage of the incident. The police has obtained FSI report according to which it has been verified that the bullets were fired from 30 bore pistol of Faiz-ur-Rehman. The accused in the case have been arrested the Chelan has been presented in the court. Now the case is in the Court of Law.

7. So far as the blocking of CNICs is concerned, the NADRA informed the Committee that the CNICs were blocked on the report of Intelligence agency and DCI of the concerned agency. For clearance of the CNICs the proper course of action will have to be adopted by the applicants.

8. After a detailed deliberation on the matter, the Chairman Committee disposed of the matter
