"The Senate of Pakistan recommends to the National Assembly that in Clause 2, in sub-clause (1), for paragraph (a), the following shall be substituted, namely:-

- (a) "undisclosed assets" means all domestic and foreign assets of every kind, as specified in clause 5, which have not been declared and includes benami assets as defined in the Benami Transactions (Prohibition) Act, 2017 (V of 2017).".
