**REVISED NOTICE**

Reference this Secretariat's Notice of even number dated 2<sup>nd</sup> August, 2019. The meeting of the Senate Standing Committee on Power will be held on **3<sup>rd</sup> September, 2019 at 02:30 p.m. in Committee Room No. 1, Parliament House, Islamabad. In case of Senate session in the evening the meeting will be held at 11:00 a.m.**

2. The revised agenda before the Committee would be as under:-

- i) Briefing on the circle-wise constructions works carried out/being carried out in the IESCO, TESCO and PESCO during the last one year alongwith details of the total duration of each work, daily electricity shut down in hours in the areas for carrying out the work and reasons for not executing the construction works in the off season period.
- ii) Provision of comprehensive details of 132 KV Grid Stations constructed/under construction at various places by PESCO during the last one year with future plans in this regard.
- iii) Briefing on the way forward to regularize services of the IESCO's contingent/adhoc/contractual employees, hired since 2014, in the light of para 3 of the Government of Pakistan, Ministry of Privatization, Privatization Commission U.O. No. F. 1(1)/PSE/Hiring-Emp/PS/PC/2018 dated 23-01-2019.
- iv) **Consideration of the following recommendation of the Committee made in its meeting held on 15th January, 2019 in the matter of " non-grant of permission to POF Sanjwal Solar Power Plant to supply its surplus electricity through wheeling to the Pakistan Ordnance Factories, Wah, under the NEPRA's "Wheeling of Electric Power Regulations 2016":-**

**"The Committee recommended that the Secretary (Power Division) may convene a meeting of NEPRA, POF Sanjwal and IESCO to resolve the issue".**

- v) Any other item with permission of the Chair.
