# REPORT OF THE SENATE STANDING COMMITTEE ON NATIONAL FOOD SECURITY AND RESEARCH ON POINT OF PUBLIC IMPORTANCE RAISED BY MIR KABIR AHMED MUHAMMAD SHAHI.

I, Chairman of the Standing Committee on National Food Security And Research, have the honour to present a report of the Committee on Point of Public Importance raised by Senator Mir Kabir Ahmed Muhammad Shahi in the Senate, in its sitting held on 9th May, 2019 regarding regularization of 64 posts of 3 projects in Balochistan, and referred to the Committee for consideration and report.

3. The Committee in its meeting held on 13th, June 2019 under the Chairmanship of Senator Syed Muzafar Hussain Shah, considered the said issue. The Mover of the said agenda was invited to attend the meeting. The meeting was attended by the following members, namely:-

- 4. In the meeting the question of public importance raised by Senator Mir Kabir Ahmed Muhammad Shahi regarding regularization of 64 posts of 3 projects in Balochistan which was referred by Chairman Senate to this Committee for consideration and report, was taken up.
- 5. Senator Mir Kabir Ahmed Muhammad Shahi stated that in year 2015, 3 projects of PSDP which included the Establishment of Horticulture Research Institute Khuzdar, Livestock Research Institute Turbat and Coastal Agriculture Research Institute Lasbela, that these 3 projects had worked very well and 64 employees from Balochistan had been employed thereunder till 30th June, 2018 when these projects were completed. Senator Mir Kabir Ahmed Muhammad Shahi pleaded for the continuation of their employment. It was further stated by him that it had been agreed that these employees would be absorbed in the Aghaz e Haqooq Balochistan Project and they would be made permanent from the status of contract employees.
- 6. In response Secretary Ministry of National Food Security and Research submitted that the above said employees were contractual employees and their services ended with completion of the project.
- 7. The Committee, however, recommended that in case these projects were revived or other projects were taken up these employees would be given preference in such projects subject to them being qualified for such posts.

The report of the Committee is submitted herewith.
