

- i. Consideration of the Bill "The National Counter Terrorism Authority (Amendment) Bill, 2019 introduced by Senator Mian Muhammad Ateeq Shaikh in the House on 02-09-2019.
  - ii. Consideration of the Bill "The Islamabad Pure Food Authority Bill, 2019 introduced by Senator Sajjad Hussain Turi in the House on 02-09-2019.
  - iii. Briefing by the CDA and MCI on the following Points raised by Senator Muhammad Javed Abbasi:-
    - i. Briefing on the revised Master Plan of Islamabad with particular reference to provision of certain mega city infrastructure including mass transit system comprising of circular rail / motorway, garbage disposal, major sanitation and bulk water supply, allocation of space for health facilities universities, research and educational institutions, libraries, mosques, graveyards, stadiums and sports facilities, recreational / amusement parks and tourists sites, etc.

  - iv. Briefing by the Director General, FIA and Director General, Bureau of Emigration & Overseas Employment on the action taken so far with reference to a Suo Moto Notice taken by Chairman Committee regarding 70 Pakistanis Stranded in Iraq who went there through fake agents.
  - v. Briefing by Director General, Immigration and Passports on the Passport Offices functional and closed-down abroad at present indicating also the number of Afghan nationals who have been granted Pakistani Nationality during the last two years.
  - vi. Briefing by Chairman, National Database & Registration Authority (NADRA) on the NADRA Centres functional and closed-down abroad at present.
