I, Senator Sardar Muhammad Yaqoob Khan Nasar, Chairman of the Standing Committee on Inter-Provincial Coordination have honour to present, on behalf of the Committee, the report on the subject matter of a calling attention notice moved by Senator MianRazaRabbani in the Senate on 19thDecember, 2018 regarding formation & functioning of a separate secretariat of the CCI. The matter was referred to the Standing Committee for consideration and report.

- 3. The Committee placed the subject matter of calling attention notice on the agenda of its meetings held on 4thFebruary, 14thMarch,28th May and 16th October, 2019. In earlier discussion during the Committee meetings, Senator MianRazaRabbani (Mover), expressed dismay over the continued delay by the government in setting up of CCI secretariat. The Committee asked for a statement/update on the issue by the Minister for IPCwho could not attend the earlier sittings of the Committee.
- 4. However, during the last meeting of the Committee held on 16thOctober, 2019 under the Chairmanship of Senator Sardar Muhammad Yaqoob Khan Nasar, the Minister for IPC did attend the meeting and subject matter of calling attention notice was deliberated upon. 5. Minister for Inter-Provincial Coordination in her statement apprised the Committee that the Article 154 (3) of the Constitution, 1973 provides for establishment of a permanentsecretariat of the CCI and not a separate secretariat. She further added that still efforts are being made for an exclusive place and support to the permanent CCI Secretariat. It is pertinent to mention that proposed structure for establishment of permanent secretariat of CCI i.e. re-designation of various posts, recruitment rules/ career path etc are at various stages of concurrence/ approval in the Establishment and Finance Divisions. Similarly, the case of allocation of budget for permanent secretariat of CCI is with Finance Division. While, an exclusive place for CCI secretariat has been allocated at 2nd Floor,

6. The Committee disposed of the matter with the recommendation for establishing a permanent secretariat of Council of Common Interests (CCI) within the M/o IPC having its exclusive budget, organizational structure and premises at the earliest. Further, Finance Division may be pursued by M/o IPC for expediting the case of allocation of budget for permanent secretariat of CCI.
