- (v) To discuss the issue of outstanding payment of Rs. 24,255,000/- approximately relating to International Fabrication Company for "Replacement of 26" Dia 15 Km Shale Gas Pipeline at Uch Gas Field, near Dera Bughti, Dera Murad Jamali, Balochistan. (included on the request of Senator Dr. Jehanzeb Jamaldini).
- (vi) Any other item with permission of the Chair.
