Meeting held on 08.10.2019

- 4. The Hon'ble Senator Dilawar Khan, Convener of the Senate Implementation Committee requested the Mover Senator Aurangzeb Khan to apprise the participants on the referred matter in relation to "Problems faced by Pensioners of Levies Personnel, who performed duties in Kurram & Orakzai districts in erstwhile FATA.
- 5. Senator Aurangzeb Khan, Mover while clarifying the subject said that this actually pertains to the pensioners of Levies Personnel's who performed duties in Kurram and Orakzai Districts in erstwhile FATA not belonging to Balochistan. The SAFRON officials while taking part in the briefing informed the participants that consequent to the 25th Constitutional Amendment, the erstwhile FATA has been merged into Khyber Pakhtunkhwa therefore the said matter has now become provincial matter. It was further informed that a Committee was constituted comprising of representatives of M/o SAFRON, Secretary Law & Order, Dept. FATA Secretariat and Deputy Commissioners / Commandants of Orakzai and Kurram Levy Forces to access the financial implications. The matter now falls under the purview of the Government of Khyber Pakhtunkhwa. Presently, the administrative and controlling authority in respect of ex-Federal Levy and Khassadar forces is Home & T.As Department, Government of Khyber Pakhtunkhwa.
- 6. Considering the above facts as described in the briefing, the Committee was of the view that as the matter relates to the fundamental rights, therefore it needs to be addressed in letter & spirit. The Committee therefore decided to call upon the concerned provincial representatives in next meeting for further discussion.

Meeting held on 29.10.2019

- 7. During the meeting, the officers of the Provincial Government of Khyber Pakhtunkhwa informed the Committee that the matter is sub-juidice as the employees have filed a writ petition in the Peshawar High Court.
- 8. The Convener of the Committee was of the view that since the matter is now in the court of law therefore, the Committee should avoid take any decision or making recommendations. He in this regard sought the views of the Committee members as well as Mover who were also agreed with the viewpoint of the Convener. A briefing on the issue was however taken from the officers of Khyber Pakhtunkhwa Government.



9. After the detailed discussion and briefing by the concerned officers on the matter, the hon'ble Convener of the Committee after taking consent of the Mover Senator Aurangzeb Khan, disposed-off the matter with the following recommendations:-

The Committee advised the officers of the Provincial Government of Khyber Pakhtunkhwa to submit the decision of the Court as and when announced to the Secretary of Implementation Committee.
