(R) John Kenneth Williams, Khalida Parveen, Osman Saifullah Khan, Nauman Wazir Khattak, Muhammad Daud Khan Achakzai, Advocate, Rozi Khan Kakar, Karim Ahmed Khawaja, Islamuddin Shaikh, Farhatullah Babar, Nawabzada Saifullah Magsi, Mir Israrullah Khan Zehri, Barrister Murtaza Wahab, Mir Muhammad Yousaf Badini, Sajjad Hussain Turi And Haji Momin Khan Afridi moved the following substantive motion under sub-rule (2) of rule 218 of the Rules of Procedure and Conduct of Business in the Senate, 2012:-

The substantive motion was put to the House which was passed by 52 votes in favor and 28 against the motion.

PRESENTATION OF REPORTS OF THE COMMITTEE

1. **Senator Taj Haider**, Chairman, Committee on Delegated Legislation, presented fourth, fifth and sixth quarterly reports of the Committee, for the period from January to September, 2017, as

- required under sub-rule (3) of rule 172E of the Rules of Procedure and Conduct of Business in the Senate, 2012.
- 2. Senator Shahi Syed, Chairman, Standing Committee on Information Technology and Telecommunication presented report of the Committee on the budgetary allocation and its utilization by Ministry of Information Technology and Telecommunication and its attached departments, corporations, autonomous body etc., as required by sub-rule (4) of rule 166 of the Rules of Procedure and Conduct of Business in the Senate, 2012.
- 3. Senator Aisha Raza Farooq on behalf of Senator Muhammad Javed Abbasi, Chairman, Standing Committee on Law and Justice, presented report of the Committee on the Bill to provide a mechanism for public interest disclosures and protection of persons making such disclosures [The Public Interest Disclosures Bill, 2017].
- 4. Senator Aisha Raza Farooq on behalf of Senator Muhammad Javed Abbasi, Chairman, Standing Committee on Law and Justice, presented report of the Committee on the Bill further to amend the Constitution of the Islamic Republic of Pakistan [The Constitution (Amendment) Bill, 2017] (Amendment of Article 228), introduced by Senator Sehar Kamran, on 21st August, 2017.
- 5. Senator Abdul Rehman Malik, Chairman, Standing Committee on Interior, presented report of the Committee on the Bill further to amend the Islamabad Capital Territory Shops, Business and Industrial Establishments (Security) Ordinance, 2000 [The Islamabad Capital Territory Shops, Business and Industrial Establishments (Security) (Amendment) Bill, 2017], introduced by Senator Mohammad Azam Khan Swati, on 10th April, 2017.
- 6. Senator Abdul Rehman Malik, Chairman, Standing Committee on Interior, presented report of the Committee on the Bill further to amend the Pakistan Penal Code, 1860 and the Code of Criminal Procedure, 1898 [The Criminal Laws (Amendment) Bill, 2017], introduced by Senator Karim Ahmed Khawaja, on 21st August, 2017.
- 7. Senator Abdul Rehman Malik, Chairman, Standing Committee on Interior, presented report of the Committee on the Bill to prohibit the employment of children and to regulate the conditions of work of adolescents [The Islamabad Restriction on Employment of Children Bill, 2017], introduced by Senator Sehar Kamran, on 21st August, 2017.

POINTS OF PUBLIC IMPORTANCE

(Zero Hour)

1. Senator Aitzaz Ahsan, Leader of the Opposition pointed out the inclusion of names of two Members of the Senate in the list allegedly issued by IB of the parliamentarians having nexus with proscribed organizations. He also spoke about the proceedings initiated by PEMRA against Mr. Arshad Sharif, a journalist. Senator Mohammad Azam Khan Swati also spoke on the freedom of expression of Media. Minister for Law and Justice also spoke on the issue.

- **2. Senator Saud Majeed** spoke about the passing of substantive motion by the Senate by dropping of many other important issues which is not a good sign.
- **3. Senator Sehar Kamran** spoke about the passing of her resolution regarding the civic democratic education in the educational institutes.

The Chairman apprised the Member that under the Rules the Ministries have two month time to implement the resolutions passed by the Senate.

- **4. Senator Hidayat Ullah** spoke about the strike of students in Quaid-e-Azam University and urged the Government to fulfill their positive demands.
- **5. Senator Sassui Palijo** stated that her Bill regarding representation of all federating units in OGEA was passed by the Senate but it has not been taken up in the National Assembly.

The Chairman asked the Member to direct some member of her party in National Assembly to give notice of the Bill.

- **6. Senator Muhammad Usman Khan Kakar** spoke about the need to disaffiliate PIMS from Shaheed Zulfiqar Ali Bhutto University. The Chairman asked the Minister for Parliamentary Affairs to look into the matter of PIMS.
- 7. Senator Mukhtiar Ahmed Dhamrah @ Aajiz spoke about the quota system as discussed in the meeting of the Cabinet.

Chairman asked the Law Minister to share the points regarding quota system as discussed in the Cabinet meeting.

The Minister for Law and Justice apprised the House about the discussion made in Cabinet meeting regarding quota.

8. Senator Muhammad Ali Khan Saif spoke about the actions being taken against the Turk citizens living in Pakistan having valid and legal visa.

The Chairman referred the matter to the Standing Committee on Interior.

- 9. Senator Hafiz Hamadullah spoke about the issue raised by him regarding long queues on FC check posts at Chamman which was referred to the Committee but no action has so far been taken in that issue. Chairman asked the Chairman Committee to expedite the matter. Senator Hafiz Hamadullah also spoke about the trend of multiple marriages by the women folk.
- **10. Senator Nehal Hashmi** spoke about the violation of Article 31-G of the Constitution and the cultural war having been imposed by India on Pakistan through its movies, dramas and advertisements. He further spoke about the negative perception having been created by some media groups on electronic media.
- 11. Senator Sardar Muhammad Azam Khan Musakhel spoke about the history of FATA areas and implementation of FCR in FATA.
- **12. Senator Muhammad Mohsin Khan Leghari** spoke about the less attendance of members in the Senate. He also criticized the withdrawal of some very important issues by the Leader of the Opposition which were listed for discussion today. He made detailed statement on the water issues in the country.

- 13. Senator Sherry Rehman spoke about the hate speech and hate slogans made by Captain Safdar in the Parliament. Chairman said that it pertains to the conduct of Member of other House so if the Members want to discuss it then there is a procedure under the rules.
- **14. Senator Aurangzeb Khan** spoke about the flaws in figures of recent population census regarding FATA. He stated that many tribes who are still IDPs have not been counted.
- **15. Senator Abdul Rehman Malik** spoke about the issuance of letter by IB regarding affiliation of parliamentarians with proscribed organizations. He also spoke about the problems being faced by parliamentarians in opening of bank accounts under the doctrine of Politically Exposed Persons.

The Chairman asked the Member to bring a Bill to address the issue.

- **16. Senator Mushahid Ullah Khan** made detailed statement regarding the present political scenario in the country. Chairman ordained the Members to speak in slanderous way.
- 17. Senator Tahir Hussain Mashhadi criticized the statement made by Hafiz Hamadullah about the female folk. 18. Senator Mir Kabeer Ahmed Muhammad Shahi spoke about the multiple issues regarding unemployment in Balochistan and observance of quota.

Chairman advised the Member that he may take up all the issue in his Committee or he may bring a Calling Attention Notice to address the issue.

- **18. Senator Saleem Zia** stated that the Parliamentarian should not vote on the matters blindly but they must look into the impact of the thing they are voting upon. He also spoke about the confessions made by Ozair Baloch before the Justice of a High Court.
- 19. Senator Shahi Syed spoke about the role of Parliament in the current scenario.
- **20. Senator Professor Sajid Mir** spoke about the making of admission policy by the Government in consultation with the owners of Private Medical Colleges and no regulator has been appointed to look into the matters of admission fee etc.

Chairman advised the Member to bring a Calling Attention Notice on the issue

21. Senator Kamran Michael, Minister for Statistics regarding divorce of Christian women. He stated that to make a law is the function of the parliament which should not be assumed by the Judges of superior courts.

The Chairman prorogued the session on conclusion of its business.
