# FORMING OF QUESTION OF LAW

The Chairman framed the following question of law:-

"Whether there is inconsistency in paragraph (c), sub-rule (1) of Rule 100 of the Rules of Procedure and Conduct of Business in the Senate, 2012 regarding referral of a Bill, reported by the Standing Committee, to a Select Committee? Does it amount to undermining the recommendations/report of a Standing Committee?"

and directed Senators Aitzaz Ahsan, Syed Muzafar Hussain Shah, Javed Abbasi, Muhammad Ali Khan Saif and Saifullah Magsi to advance their arguments and assist the Chair on the same.

The Members advanced their arguments on 13<sup>th</sup> April, 2017 and after hearing the Members, the Chairman gave his detailed ruling on the issue on 18<sup>th</sup> April, 2017.

#### REPORT LAID BEFORE THE SENATE

1. Mr. Zahid Hamid, Minister for Law and Justice on behalf of SENATOR MOHAMMAD ISHAQ DAR, Minister for Finance, Revenue, Economic Affairs, Statistics and Privatization, laid before the Senate the Second Quarterly Report for the year 2016-2017 of the Central Board of Directors of the State Bank of Pakistan on the state of Pakistan's Economy, as required under section 9A (2) of the State Bank of Pakistan Act, 1956.

# **MOTION (Under Rule 172A)**

Senator Raja Muhammad Zafar-Ul-Haq, Leader of the House, moved under rule 172A of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the House may constitute itself into a Committee of the Whole to develop a strategy that addresses the increasing threat of Water scarcity to the Federation.

The Motion was put to the House and adopted.

# **CONSIDERATION OF ADMISSIBILITY OF ADJOURNMENT MOTIONS**

1. Senator Col. (R) Syed Tahir Hussain Mashhadi moved Adjournment Motion No. 1- 261/2017-M to discuss the present threat to the people of Pakistan as witnessed in recent terrorist attacks in Peshawar, Mohammad Agency, Lahore and Sehwan Sharif and the State's knee-jerk response to the new spate of terrorist acts and outrages.

After hearing the Mover, the Chairman held the Motion out of order.

2. Senators Mohammad Azam Khan Swati and Sirajul Haq moved Adjournment Motion No. 5, 8-261/2017-M, to discuss the recent price hike in basic food items which has further exacerbated the financial position of poor people.

After hearing the Movers, the Chairman held the Motion in order and fixed the same for two hours discussion on 18th April, 2017.

**3.** Senator Col. (R) Syed Tahir Hussain Mashhadi was to move the Adj. Motion No. 1 (2-261/2017-M), to discuss the alarming rise in the use and selling of drugs among university students.

However, the Chairman suggested the Member to move a Motion under rule 218 so the Member withdrew his motion.

- 4. Senator Mohsin Aziz was to move the Adj. Motion No. 2 (4-261/2017-M), to discuss the decision of the Government to privatize three international airports of Karachi, Lahore and Islamabad through an executive order which could be a security threat to the strategic assets of the country. However, the Chairman informed the Member that the matter has already been referred to the Standing Committee, therefore, the Adjournment Motion was withdrawn by the
- Member.5. Senator Syed Shibli Faraz was to move the Adj. Motion No. 3 (6-261/2017-M), to discuss the serious structural issues in power sector resulting into perpetual crisis affecting the daily lives of

However, the Chairman suggested the Member to move a Motion under rule 218 so the Member withdrew his motion.

**6.** Senator Mian Muhammad Ateeq Sheikh moved the Adj. Motion No. 2 (9-261/2017-M), to discuss the implications, causes and motive behind suicide attack on a census team at Lahore resulting into death of seven personnel.

After hearing the mover, the Chairman held the Motion out of order.

**7.** Senator Mian Muhammad Ateeq Sheikh moved the Adj. Motion No. 1 (11-261/2017-M), to discuss the unjustified over billing to the domestic as well as commercial consumers by MEPCO in order to cover huge losses.

The member explained the salient features of the Adjournment Motion.

The opposition benches staged a walkout due to absence of Minister concerned.

The Chairman took serious note of non-attendance of ministers as a matter of routine and directed that it will not be accepted that Senate be treated or degraded this way.

The Chairman adjourned the Senate Sine Die in terms of rule 23, sub rule 2(a), Rules of Procedure and Conduct of Business in the Senate, 2012.

**8.** Senator Sirajul Haq moved the Adj. Motion No. 1 (7-261/2017-M), to discuss the baton charge and firing by the Police on a peaceful sit-in lodged by Jammat-e-Islami at Shahrah-e-Faisal Karachi against over billing and unscheduled load shedding of electricity by K-Electric.

The Chairman held the motion out of order as it pertains to Law and Order which is a provincial subject.

**9.** Senator Nawabzada Saifullah Magsi moved the Adj. Motion No. 2 (10- 261/2017-M), to discuss the implications of the decision of World Bank's Tribunal namely Court for International Dispute Settlements regarding a case between the Government of Balochistan and Tethyan Copper Company.

The Chairman held the motion in order and fixed the same for discussion on Thursday the 20th April, 2017 as last item.

**10.** Senator Mian Muhammad Ateeq Sheikh moved the Adj. Motion No. 1 (12-261/2017-M), to discuss the disappearance of Col. (R) Habib, resident of Rawalpindi in the hands of the Indian forces on his visit to Nepal.

Mr. Sartaj Aziz, Advisor to the Prime Minister on Foreign Affairs made a statement explaining the facts of the case and the steps taken by the government in this regard so far. After the statement by the Advisor, the Chairman asked the Mover that whether he still

presses his Motion or not.

# PROTEST BY THE OPPOSITION BENCHES

Senator Aitzaz Ahsan, Leader of the Opposition recorded protest on behalf of the joint opposition against the decision of the Supreme Court whereby two senior judges have declared the Prime Minister as incompetent to remain prime minister. He was of the view that the Prime Minister has no legal and moral standing to remain as prime minister of Pakistan.

Following Members also spoke on this issue:-

At this stage, the opposition benches chanted slogans against the Prime Minister. The Chair ordained the Members not to chant slogans. The Chair ordained Senator John Williams not to raise military calls/voices in the House.

# POINTS OF PUBLIC IMPORTANCE

- 1. Senator Farhatullah Babar pointed out taking into custody of Mr. Ashfaq Laghari and Mr. Gulam Qadir by the Law enforcement Agencies and their non-production before the courts of law within 24 hours. Senators Hari Ram and Mukhtiar Ahmed Dhamra @ Aajiz also spoke on the same issue.
  - The Chairman asked the Member to take up the matter in the Functional Committee on Human Rights. The Chairman further directed to send the verbatim to the Minister for Interior.
- Senator Sajad Hussain Turi spoke about the less amount of compensation being given to the affectees of terrorist activities in FATA which is less than the compensation being paid in other parts of the country.
- **3.** Senator Sardar Muhammad Azam Khan Musakhel spoke about releasing of funds allocated by the Federal Government.
- **4.** Senator Syed Tahir Hussain Mashhadi spoke about heavy load shedding of electricity in the country. Senator Mukhtiar Ahmed Dhamra @ Aajiz also spoke on the same issue.
- 5. Senator Muhammad Usman Khan Kakar pointed out the arrest of his party worker only due to pointing out of suspension of internet services. He further pointed out the agitation lodged by the women in Press Club Loralai
- **6.** Senator Dr. Jehanzeb Jamaldini pointed out that National Commission of Human rights funds were not provided by the government.

- 7. Senator Nehal Hashmi pointed out the demolishing of heritage building of a school in Karachi by unknown persons. Senator Taj Haider responded the issue and assured that he will inform the house after getting report from the government of Sindh.
- **8.** Senator Mukhtiar Ahmed Dhamra @ Aajiz appreciated the efforts of the Government towards the release of a Pakistani engineer in Sudan.
- 9. Senator Muhammad Azam Khan Swati pointed out the non-releasing of funds for the coal power project initiated by Dr. Samar Mubarak Mand. Senator Taj Haider submitted the point of view of Sindh government in this regard.
- **10.** Senator Mushahid Hussain Syed spoke about the possible reaction of the Indian government in the wake of decision to hang Kulbushan Yadev.
- 11. Senator Taj Haider spoke about the disappearance of close allies of Mr. Asif Ali Zardari from Sindh and their non-production before the courts.

The Chairman directed the Minister of State for Interior to respond the issue tomorrow.

12. Senator Tahir Hussain Mashhadi spoke about the missing persons belonging to MQM.

The Opposition staged walkout as protest against enforced disappearances.

- **13.** Senator Sardar Muhammad Azam Khan Musakhel pointed out the non-payment of salaries to paramedical staff of Poly Clinic for last nine months.
- **14.** Senators Kalsoom Parveen and Dr. Jahanzeb Jamaldini spoke about the issues relating to elections in PMDC.

The Chairman directed to send the verbatim to the Minister concerned with the direction to respond the same in the House on Friday the 14th April, 2017.

- **15.** Senator Taj Haider submitted report in the House regarding the incident of demolishing of a heritage building of school in Karachi and assured that the Government of Sindh will take serious action in this regard.
- **16.** Senator Muhammad Azam Khan Swati drew attention of the Government towards Free Trade Agreement with Turkey which is affecting the local manufacturing industry in Balochistan, FATA and Khyber Pakhtunkhwa.
- 17. Senator Kalsoom Perveen pointed out that PIA is using grounded ATR aircrafts for their outbound flights from Islamabad to Quetta.

The Chairman directed the Member to come in his Chamber so that the matter can be resolved.

**18.** Senator Syed Muzaffar Hussain Shah pointed out the reduction in the purchase of wheat by PASCO from the provinces due to the reasons that their disposal has become low.

The Chairman directed that the verbatim may be sent to the Ministry of Finance for ministerial response.

- 19. Senator Nehal Hashmi raised that 12 Pakistanis detained in Indian jails and are not being released despite the fact they have completed their sentences. He condemned the Indian government and anti-Pakistan statements of Foreign Minister of India.
- **20.** Senator Sassui Palijo raised the matter of extensive load shedding in Sindh and also pointed out the shortage of Sui Gas in the province.
- **21.** Senator Professor Sajid Mir pointed out that the technicians hired in Federal Government Polyclinic Hospital Islamabad are not being paid their respective salaries since last 7 months.

The Chairman directed that the matter be sent to the Minister for CADD but not for ministerial response but only for his information.

- 22. Senator Sherry Rehman raised the matter of shortage of Sui gas and the extensively high pricing of Sui gas in Sindh province. She further pointed out the matter of load shedding in Sindh. Furthermore she raised multiple issues relating to Foreign Policy of Pakistan and criticized the weaknesses in the Foreign Policy of Pakistan. She also condemned the recent aggressive statements by the Indian Foreign Minister.
- 23. Senator Muhammad Usman Khan Kakar stated that transparency should be observed during collection of data for population census in Balochistan and FATA and the foreigners should not be counted in that. Senator Dr. Jahanzeb Jamaldini also spoke on the issue.
- **24.** Senator Lt. General (R) Salahudin Tirmizi appreciated the efforts of the Chair and the House in resolving the issue regarding New Balakot City Project.
- **25.** Senator Muhammad Azam Khan Swati pointed out the spurious drug in the market that creates the artificial hype and over pricing of the Hepatitis Drug in the market.
- **26.** Senator Sassui Palijo pointed out the violation of article 158 and the matter of electricity and Sui Gas load shedding in Sindh.
- 27. Senator Sherry Rehman also spoke on the matter of extensive electricity and Sui Gas load shedding in Sindh. She further pointed out that all the foreign scholarships are being offered only to Punjab. She pointed out lack of diplomatic abilities of the Government.

The Chairman directed the secretariat to call on the Minister of state for Petroleum tomorrow i.e. 14th April, 2017 to respond on the question raised by Senator Sassui Palijo and Senator Sherry Rehman.

- **28.** Senator Mir Kabir Ahmed Muhammad Shahi pointed out the non-availability of Hepatitis Drug in the country. He further raised the issue of Sui Gas in Balochistan.
- **29.** Senator Nehal Hashmi pointed that employees of Workers Welfare Board KPK have not been paid their due salaries since last ten months.

The Chairman directed to refer this matter to Senator Mohammad Azam Khan Swati.

- **30.** He further pointed out various issues of bad governance in Sindh.
- **31.** Senator Taj Haider pointed that worker welfare funds have not been released by the Federal government. He further pointed out that no action has been taken by the government in the case of disappearance of close allies of Mr. Asif Zardari. He also spoke on the matter of blocked CNICs.
- **32.** Senator Sardar Muhammad Azam Khan Musakhel pointed out the discriminatory allocation of posts in the Geological Survey of Pakistan. He further pointed out that the Director General Geological Survey of Pakistan does not attend his office in Quetta and he usually remains present in Islamabad.

# The Chairman referred the matter to the Minister concerned with the direction that the same may be fixed for ministerial response on Friday i.e. 21st April, 2017.

- **33.** Senator Muhammad Usman Khan Kakar pointed out that the imposition of ban on supply mof fertilizers in Balochistan and FATA.
- **34.** Senator Taj Haider pointed out the serious matter of 3500 missing people in the Country. He urged the House to take some initiative to resolve this issue.
- **35.** Senator Sherry Rehman pointed out the extensive load Shedding and power crisis in the Country.
- **36.** Senator Sassui Palijo also pointed out the matter of extensive load shedding in Sindh and Punjab. She further spoke about the joining of terrorist organization by one Naureen Leghari through social media and urged the Government to keep a watch on such websites.
- **37.** Senator Mir Kabir Ahmed Muhammad Shahi pointed out the posts lying vacant in ZTBL in Balochistan. He further criticized the working of ZTBL in Balochistan and stated that the farmers of Balochistan are not getting any support from ZTBL.
- **38.** Senator Dr. Jahanzeb Jamaldini pointed out the need of electricity in District Panjgoor Balochistan which is very rich in dates production. He further spoke about the need of installation of a grid station in Tehsil Dagh Esa Chah District Naushkee Balochistan.
- **39.** Senator Nawabzada Saifullah Magsi pointed out the delay in completion of two projects of Water and Power in Jhal Magsi due to non-releasing of funds by the Federal Government i.e. Pat Feeder Canal extension and RBOD-3.

# The Chairman directed the member to move a Calling Attention Notice.

- **40.** Senator Nehal Hashmi pointed out the matter of lack of nutrition in Thar for which the State is collectively responsible.
- **41.** Senator Muhammad Ali Khan Saif pointed out the worse condition of PIMS Hospital Emergency unit, Islamabad. He criticized the Government on spending of the money on State advertisements. He further pointed out the incident of killing of Mishaal Khan a student of AWKU Mardan and urged the Government to refer his case to Military Court to set an example.

**42.** Senator Prof. Sajid Mir pointed out the non-payment of salaries to the technicians in Poly Clinic Federal Hospital Islamabad.

# The Chairman directed that the verbatim be sent to the Ministry once again.

- **43.** Senator Sardar Muhammad Azam Khan Musakhel pointed out that Qatar promised the Prime Minister of Pakistan to give jobs to one lac Pakistanis but the promise has not been fulfilled yet. He further pointed out that Districts Musakhel, Chagi and Qilla Saifullah have been allotted as hunting sites for Qatri princes by the Federal Government while bypassing the provincial Government.
- **44.** Senator Taj Hiader spoke about the high rates of solar energy in Pakistan as compared to other regional countries like Dubai.
- **45.** Senator Karim Ahmed Khawaja pointed out sea intrusion in some areas of Sindh and Balochistan.
- **46.** Senator Samina Abid pointed out that the invasion by terrorists from areas of Afghanistan and nooristan to the Chitral valley. She urged the Government to make arrangements for security of the people of the area.

# The Chairman suggested the Member to move a Calling Attention Notice.

- **47.** Senator Dr. Jahanzeb Jamaldini pointed out that marine life of coastal area Balochistan has been destroyed by international trailers.
- **48.** Senator Abdul Rehman Malik pointed out the killing of a Pakistani national who came from abroad but he was killed by some masked women at Sialkot on the allegation of blasphemy.

The Chairman directed the Secretariat to send the verbatim to the Minister of State for Interior for ministerial response in the House.

The Chairman prorogued the 261st session on 21st April, 2017 on conclusion of its business.
