The hon'ble Senator Muhammad Ali Khan Saif, Mover, apprised the Committee about the matter regarding the "arrest of a Pakistani citizen in the Kingdom of Saudi Arabia due to expiry of his visa" and said that the parents of a Pakistani citizen have approached him and sought help to get released their son who is imprisoned in the jail in Kingdom of Saudi Arabia due to the reason of over staying in the country after expiry of his visa. He further said that the Pakistani Mission is not providing assistance of any kind in this regard.
- 5. The Special Secretary, M/o Foreign Affairs informed the Committee that since the particulars of the arrested person were not provided by the hon'ble Senator, therefore it was difficult to trace out the case. However, the Mission in Kingdom of Saudi Arabia has been directed to take necessary action in this regard and provide all necessary assistance in order to get him released if he is not involved in any kind of serious crime.
- 6. After the statement of the Foreign Office, the hon'ble Chairman of the Committee with the consent of the Mover, disposed-off the matter.
