2. The agenda before the Committee would be as under:-

- i) Consideration of point of Public Importance regarding "scheduled power shutdown in the Gadoon Industrial Area for the last three months" raised by Senator Sitara Ayaz during the Senate sitting held on 14th January, 2020. The Chairman Senate referred the matter to the Standing Committee on Power for consideration and report.
- ii) Consideration of point of Public Importance regarding "effects of Thar Coal Project on local people" raised by Senator Gianchand during the Senate sitting held on 24th January, 2020 and the Chair referred the matter to the Standing Committee on Power for consideration and report.
- iii) Bi-annual (July-December 2019) examination of the budgetary allocation and its utilization by the Ministry of Energy (Power Division) as required under rule 166(4) of the Rules of Procedure and Conduct of Business in the Senate 2012.
- iv) Briefing by the CPPA(G) on the outstanding dues on account of energy purchase price and indexation of 81 MW Malakand-III HPS & 18 MW Pehur HPS.
- v) Briefing by the PESCO on the following:-
 - a) Non-provision of electricity connections to the newly established industrial units in Dargai Industrial Estate.
 - b) Progress on the; i) recommendation made by the Committee during its meeting held on 02-04-2019 regarding stoppage of bulk supply to the Afghan Refugees Camps in KPK and allocation of all the connections as per NEPRA rules, as suggested by Senator Nauman Wazir Khattak; and ii) recovery of arrears against the bulk/individual meters installed in the Camps and action taken against all those involved in the electricity theft that has caused huge financial loss to the PESCO.
 - c) Progress on the inquiry into the case of recovery of 600/650 stolen transformers of PESCO by FIA from a private store
- iv) Any other item with permission of the Chair.
