[At 12:18 p.m. Senator Moula Bux Chandio pointed out that the House was not in Quorum thereafter the Chairman directed that the count be made wherein it was found that the House is not in Quorum and the bells were rung for 5 minutes. After ringing of the bells, the count was made again and the House was not in Quorum thereafter the Chairman Senate adjourned the proceedings of the House to meet again on Monday.]
