After ringing of the bells, the count was made again and the House was in Quorum.]

[At 11:30 a.m. the opposition ended its walk out.]

REPORT OF THE STANDING COMMITTEE-PRESENTATION OF:

Senator Mirza Muhammad Afridi, Chairman, Standing Committee on Commerce and Textile Industry, presented report of the Standing Committee on the subject matter of starred question No. 167, asked by Senator Mir Kabeer Ahmed Muhammad Shahi on 7th March, 2019, regarding the number of persons working in Textile Division, its attached departments, authorities, corporations, autonomous/semi-autonomous bodies and organization.

The report stood laid.
