

2. The agenda before the Committee will be as under:-

 - vi) Consideration of a letter/petition of All Pakistan Textile Mills Association (APTMA), addressed to the Honourable Chairman Senate, regarding "competitive cost of electricity to industry for sustained economic growth."
 - vii) Consideration of a petition of Mr. Ozair Ayaz Khan [B.E. (Mechatronics)] complaining against PESCO for not calling him for interview for the post of SDO/Junior Engineer despite the fact that he had passed the written test of the said post, conducted by the CTS in February, 2020, with 61 marks vide Roll No.1412628.
