

3. Only two officers, not below BS-20, from Ministries/Divisions invited to the meeting, shall attend the meeting.
4. All respected Senators and every other individual entering the Parliament House will go through thermal-gun screening.
5. Parliamentary Reporters Association will shortlist 5 journalists / reporters for entry into the Committee Rooms in view of limited space.
6. All respected Senators and other attendees will use face mask, gloves and sanitizer during the meeting.
