## **RESOLUTIONS**

1. Senator Sitara Ayaz on her behalf and behalf of Senators Mushahid Hussain Syed, Muhammad Akram, Pervaiz Rashid, Sana Jamali and Faisal Javed moved the following resolution:-

"This House recommends that the Government should construct "Small Rubber Dams", which have low cost and less construction time compared to the conventional dams, in Islamabad Capital Territory, for storage of water, provision of clean drinking water and generation of hydropower electricity on captive mode."

**The Resolution was not opposed and unanimously passed by the House.**

2. Senator Sirajul Haq moved the following resolution:-

"This House recommends that the Government should withdraw the authority of the Pharmaceutical Companies, granted to them under the Drug Policy of the Government, regarding the annual increase of 50% in the prices of medicines."

**The Resolution was withdrawn by the Member in view of the statement of the Minister.**

3. Senator Samina Saeed to move the following resolution:-

"This House recommends that the Government should take necessary steps to establish separate lock ups for the custody of juveniles arrested in suspicion of committing crimes in

order to keep them separate from adult criminals in lock ups, in all police stations in Islamabad Capital Territory.”

**The Resolution was deferred.**

**4. Senator Khushbakht Shujat** moved the following resolution:-

“This House recommends to the Government to make arrangements for First Aid and Civil Defence Training in the educational institutions under the administrative control of the Federal Government in order to enable the youth to cope with any kind of emergency/accident in efficient-manner and save loss of human life and property.”

**The Resolution was not opposed and unanimously passed by the House.**

**30. Senator Mushtaq Ahmed** moved the following resolution:-

“This House Reiterates that ALLAH ALMIGHTY revealed the Holy Quran to His last Messenger, Hazrat Muhammad (SAW) which is the final word of ALLAH ALMIGHTY and a complete source of guidance for the mankind till the day of judgement; Recognizes the fact that our young generation is facing a number of problems and challenges on ideological and moral fronts mainly due to lack of true understanding of the teachings of the Holy Quran and Sunnah; Shows concern on the fact that there is no proper system of the teachings of the Holy Quran and Sunnah in the educational institutions in the country which has created an ideological gap in the minds of our youth; Considers it essential that the meaning and teachings of the Holy Quran should be taught in Urdu in all the universities under the administrative control of the Federal Government in the light of Articles 2, 31(2)(b) and 227 which provides for the Holy Quran and Sunnah to be the supreme law of the land and to promote their teachings in the country; and Therefore, the House recommends and urges upon the Government to make necessary arrangements for the teaching of the Holy Quran with Urdu translation in all the universities under the administrative control of the Federal Government in the country.”

**The Resolution was not opposed and unanimously passed by the House.**

1. Senator Abdul Rehman Malik, Chairman, Standing Committee on Interior, presented report of the Standing Committee on the Bill further to amend the Anti-terrorism Act, 1997 [The Anti-terrorism (Amendment) Bill, 2020].

3. Senator Sardar Muhammad Shafiq Tareen, Chairman, Standing Committee on Narcotics Control, presented report of the Standing Committee on the Bill further to amend the Control of Narcotic Substances Act, 1997 [The Control of Narcotic Substances (Amendment) Bill, 2020].

## **LEGISLATIVE BUSINESS**

1. Mr. Ali Muhammad Khan, Minister of State for Parliamentary Affairs on behalf of Mr. Ijaz Ahmad Shah, Minister for Interior, to move that the Bill further to amend the Anti-terrorism Act, 1997 [The Anti-terrorism (Amendment) Bill, 2020], as reported by the Standing Committee, be taken into consideration at once.

**The Motion was put to the House which was opposed by the Members of JI and JUI however, the same was adopted with majority. Thereafter, the House started second reading of the Bill i.e. clause by clause consideration.**

2. Mr. Ali Muhammad Khan, Minister of State for Parliamentary Affairs on behalf of Mr. Ijaz Ahmad Shah, Minister for Interior, to move that the Bill further to amend the Anti-terrorism Act, 1997 [The Anti-terrorism (Amendment) Bill, 2020], be passed.

**The Motion was put to the House and the Bill was passed with majority.**

- Senator Molana Abdul Ghafoor Haideri spoke about incident of attack on MPA in Balochistan. **Chair directed to seek report from Chief Secretary and IGP.**
- Senator Tahir Bizenjo spoke about killing of Hayat Baloch in Balochistan a University student in Turbat kech at the hands of FC soldier.
- Senator Molvi Faiz Muhammad endorsed the bill introduced by Javed Abbasi about compulsory Arabic Language. He also spoke about desecration of Holy Quran in a village "Jakhar". He also spoke about attack on Mr. Zabid MPA from Balochistan. He also spoke about devastation caused by rain in Balochistan and demanded that special relief may be given to devastated areas of Balochistan. He also spoke about Pakistan-Saudi relations which has a long history.
- Senator Atta Ur Rehamn spoke about the incident of desecration of Holy Quran by a Qadiani at D.G Khan village Jakhar. He further stated that police arrested the accused and also mounted baton charge on protestors. He also spoke about coming of Qadianis in limelight since this Government came into power. **The Chairman directed to seek report from Chief Secretary Punjab and IGP.**
- Senator Mushtaq Ahmad spoke about increasing tendency of incidents of blasphemy. He also spoke about killing of Hayat Baloch a student of Karachi University at the hands of FC.
- Senator Sirajul Haq spoke about closing of schools in Malakand division since January and non-payment of salaries to private school teachers.
