**REVISED NOTICE**


In continuation of the earlier meeting of the Standing Committee on States and Frontier Regions (SAFRON) held on August 25, 2020, a follow-up meeting of the Committee will be held on **September 21, 2020 at 11:30 AM in Old PIPS Hall, Parliament Lodges, Islamabad.** However, in case Senate is sitting in the morning the committee will meet at 2:30 PM.

2. The **AGENDA** before the Committee would be as under:

- i. Briefing by Federal Secretary Petroleum, Chief Secretary Khyber Pakhtunkhwa and MD SNGPL on way forward regarding fund arrangements for supply of Gas to erstwhile FATA, as discussed in meeting of Senate Standing Committee on SAFRON, held on 6<sup>th</sup> February and 2<sup>nd</sup> March, 2020 wherein, after a detailed deliberations, the following recommendations were made:
  - a. Provincial Government, Khyber Pakhtunkhwa was directed to a initiate a process for consultation to timely prepare future plans with SNGPL for inclusion in the proposal for submission to the provincial Cabinet for approval before budget 2020-21; and
  - b. The project for provision of gas to the erstwhile FATA / Tribal districts should be materialized in 2020-21 as it has been pending since 2009-2010. The committee directed SNGPL to resolve the issues of survey, project design, revised estimated cost, allocation/ release of funds with coordination of Provincial Government and M/O Energy (Petroleum Division) at the earliest and initiate the project without further delay.
- ii. Briefing by Additional Chief Secretary and Secretary Local Government Khyber Pakhtunkhwa on the implementation status of the following recommendations:
  - a. The committee strongly recommended that all the ad-hoc and daily wages employees working in erstwhile FATA may be adjusted and no employee shall be laid off as committed with the people of FATA before merger; and
  - b. The committee recommended to adjust the ad-hoc employees of small dams/ power sector and road infrastructure of FATA Development Authority and the Data Entry Operators appointed by NADRA in March, 2017 in Tribal districts.
- iii. Point of Public Importance raised by Senator Muhammad Usman Khan Kakar regarding compensation to the IDPs from South Waziristan/FATA.
- iv. Implementation Status of/compliance report on the recommendations given during the meeting held on 25th August 2020.
- v. Briefing by Home Secretary Khyber Pakhtunkhwa and concerned Deputy Commissioner on "Ibaadkhel and Kimaatkhel areas of Kohat may be given the status of Tehsil as these areas fulfill the criteria required for the status of Tehsil".
- vi. Briefing by Additional Chief Secretary, Special Secretary Newly Merged Districts and Secretary, Planning & Development Khyber Pakhtunkhwa on total budget allocation in 2019-20 and 2020-21 for Merged Districts (District-wise) in all sectors and share of Parliamentarians (Senators, MNAs and MPAs) in the same.
