4. The Committee had detailed discussion on the agenda of Senator Mushtaq Ahmed Khan. While discussing the agenda item the Mover contended that an in appropriate content about Pashtoon Community was published by GABA publishers. It was something intentional. The people of Bonair have a very bright

history. The mover called this as a criminal negligence both on the part of the government of Khyber Pakhtoonkhwa and the publisher. The committee recommended to ban the books immediately.

- 5. The committee was told that the Provincial Government was in the knowledge of this issue. Action is being taken against the culprits and F.I.R. will be lodged against them.
- The committee disposed of the matter with the recommendation to sensitize all the text book boards about the gravity of the situation through a letter.
