2. The Mover Senator Bahramand Khan Tangi highlighted that although relevant information has been provided by the Division, the verified copies of the academic degrees and experience certificates may also be provided to the Committee. He added that the details of fringe benefits being provided to the Chairman PTV may also be provided to the Committee. He expressed concerns over hefty salaries and perks being provided to the Managing Director PTV.

3. The Chairman Committee opined that both the Chairman and the Managing Director of PTV are foreign qualified and accomplished professionals. He added that market competitive salaries for professionals are essential for the PTV to compete with the market competitors and improve the performance of the corporation.

4. The Committee decided to take up the human resource structure of PTV as a separate agenda in forthcoming meeting to discuss the matter in detail and directed that verified copies of the academic degrees and experience certificates of Chairman and MD PTV may be provided to the Committee. It was further directed that details of fringe benefits being provided to the Chairman PTV may also be given to the Committee.

5. The Committee with the consent of the Mover disposed of the matter for onward report to the House.
