- 4. Secretary, Ministry of Foreign Affairs briefed the Committee that in accordance with the two Vienna conventions - diplomatic Relations 1961 (VCDR-61) and Consular Relations 1963 (VCCR-63) - the Government of Pakistan accords various privileges to Diplomats and Consular Officers for official as well as personal use. In the subject matter, this Ministry was informed that the Customs authorities conducted an information based operation on 1st July 2020 and recovered two vehicles of Palestinian Embassy from the house of a Pakistani citizen. On receipt of seizure report from the Customs Authorities, a Note Verbale has been sent to the Palestinian Embassy seeking information. Furthermore, the matter is sub-judice before the court of law. The Ministry also submitted that the impounding of personal diplomatic vehicles is an administrative matter, with no linkage to any political aspects of the Palestinian issue.
- 5. Senator Mushahid Hussain Sayed, Mover of the subject matter showed satisfaction on the response provided by the Ministry of Foreign Affairs, therefore, the Committee disposed off the instant matter.
